Chairman Sakamoto and Members of the Committee:

Since approval of our recent amendments to our administrative rules by the Governor, we have a Code of Ethics to guide our work on drafting rules for revoking, suspending, denying and reinstating a teacher's license. My colleagues and I have, for the past several months, been reviewing the rules used in several other states and identified elements that we believe are needed in ours.

We have also had very heavy discussions about these elements because we fully understand the impact that revoking, suspending, or denying a teacher's license will have on the teacher's ability to seek or keep employment. License revocation due to a teacher's conviction of a sexual offense has been one of these heavy topics of discussion. The Board shares SB 2080's serious concern about protecting our children from those who have committed such offenses.

We believe that the provisions of SB 2080 should be spelled out in administrative rules rather than in statute. But we also know that in previous sessions, the Legislature has passed measures that spelled out a specific condition under which a teacher's license should be revoked. For this reason, if this bill should pass, we believe that it should become part of §302A-807.
