Title:

S.B. 2080, SD2 (SSCR2736). Relating to teacher licensure.

Purpose:

To require the Hawaii Teacher Standards Board to revoke a teacher's license when the teacher has been convicted of certain sexual offenses against a minor.

Department's Position:

The Department of Education (Department) supports S.B. 2080, SD2 (SSCR2736) which requires the Hawaii Teacher Standards Board (HTSB) to revoke a teacher's license when the teacher has been convicted of certain sexual offenses against a minor. The safety of our students is paramount. It should be noted that HTSB is currently incorporating the revocation of teacher licenses based on convictions of sexual/other offenses into their administrative rules, making statutory changes unnecessary if the new rules are adopted before this proposal can be enacted. The Department is not the only agency that employs teachers with a Hawaii teaching license. Independent schools and charter schools also employ teachers. As such, the Department respectfully requests the following changes to Section 1 (d) of S.B.2080, SD2 to read as follows: "provided that the Department of Education, independent school agency or charter school agency in Hawaii [shall identify notify the Board of the teachers for whom this section applies and the Board shall notify the clerk of the court of each individual identified [by the department as a teacher who is being tried by the court of a sexual offense, as described in subsection (a)."

The Department's proposed amendment is intended to protect all students.

Chairman Takumi, Chairman Sonson and Members of the Committees:

Since approval of our recent amendments to our administrative rules by the Governor, we have a Code of Ethics to guide our work in drafting rules for revoking, suspending, denying and reinstating a teacher's license. My colleagues and I have, for the past several months, been reviewing the rules used in several other states and we have identified elements that we believe are needed in ours.

We have also had very heavy discussions about these elements because we fully understand the impact that revoking, suspending, or denying a teacher's license will have on the teacher's ability to seek or keep employment. License revocation due to a teacher's conviction of a sexual offense has been one of these heavy topics of discussion. The Board shares SB 2080 SD2's serious concern about protecting our children from those who have committed such offenses.

We believe that the provisions of SB 2080 SD2 concur with our Board's thinking and should this bill pass, we have no problems with incorporating it into our administrative rules. We understand the seriousness of these crimes and feel that statutory language will provide strong support for our proposed rule changes. We believe that §302A-807 is the section where these provisions should be added.
