TESTIMONY OF THE CHAIRPERSON OF THE BOARD OF LAND AND NATURAL RESOURCES

on SENATE BILL 2154 – RELATING TO A PILOT COMMUNITY CONSERVATION PROGRAM

BEFORE THE SENATE COMMITTEE ON WATER AND LAND

February 11, 2008

Senate Bill 2154 proposes to establish a five-year pilot community conservation program to educate ocean resource users on resource protection laws within the Department of Land and Natural Resources' (Department) Division of Conservation and Resources Enforcement (DOCARE), Maui Branch. While the Department supports the intent of this bill, the Department nonetheless has concerns with the fiscal implications this bill will have on the Executive Supplemental Budget request and the impact on the Department's request to increase statewide conservation resource enforcement staffing.

The pilot community conservation program called for in this bill would train volunteers in resource laws and enforcement, conduct education and outreach to natural resource users, coordinate with makai watch communities, enforce all natural resource laws, and identify new rules necessary to ensure long term sustainability of near-shore marine resources. The bill also proposes to establish additional conservation and resources enforcement officer supervisory positions, an accountant position, an educational specialist position, a research statistician position, a mechanic's positions, and additional clerk typist positions within DOCARE's Maui Branch.

The Department supports providing additional staff and funding resources for the Department's DOCARE branches across the State, and the Department has been working closely with the Legislature to obtain the necessary funds for this broader initiative. While the Department applauds the intent of this bill and the passion of our Maui residents, the Department must be mindful that all our islands are crying out of additional enforcement. Rather than passing out this measure, the Department respectfully asks for the Legislature's support of the addition of eleven conservation and resources enforcement positions and four clerk typist positions for deployment statewide to each of the four counties as identified in the Department's supplemental budget request. These additional positions would increase needed staffing statewide and would help improve conservation enforcement capabilities in each of the four counties.

Aloha Chair Hee and committee members. My name is Kuhea Paracuelles and I am the Environmental Coordinator for the County of Maui. Thank you for this opportunity to testify this afternoon in support of Senate Bill 2154, which establishes a five-year pilot community conservation program to educate ocean resource users on resource protection laws within the moku of Lahaina and the moku of Kaanapali. Both of these are high use areas by residents and visitors and merit a closer look.

I find this pilot program both exciting and sensible. It takes advantage of community partnerships that are already in place and builds upon that foundation. It works to empower the community through consistent educational opportunities and helps them to make better decisions about when and how they interact with Maui's ocean resources. It allows DOCARE officers to become intimately familiar with the natural resources, conservation issues, and people of these areas. They will become people that the community will trust because they know that these DOCARE officers are committed to these areas and know what's going on day to day.

While the cost of conducting this pilot program may sound too extensive to some, when you compare that cost, \$650,000 over five years, to the millions of dollars worth of ecosystem goods and services that are being protected each year, it quickly proves itself a highly worthy investment. We stand to lose more than we could ever imagine if we don't attempt something as bold and innovative as what is proposed in this bill. The savings would not justify the ultimate loss.





The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u>, <u>with</u> <u>amendments</u> S.B. 2739, which would place the Mäkena-Keoneÿöÿio Government Road under the jurisdiction of the Department of Land and Natural Resources (DLNR).

The bill would limit public access to the portions of the road that pass through the ÿÄhihi-Kïnaÿu Natural Area Reserve (NAR). Access would be permitted to legal residents who use the road to access their homes; state and county officials conducting maintenance of the road or the Natural Area Reserve and its resources (NAR); and persons permitted into the NAR under administrative rules adopted by the DLNR.

OHA appreciates the intent of S.B. 2739. OHA understands that the recent publicity given to the ÿÄhihi-Kïnaÿu NAR has caused a marked increase in visitors to the area. A study conducted sometime before 2003 found that about 700 people per day visit the NAR, which means that an incredible amount of unneeded stress is being placed on the site's vast natural and cultural resources.

OHA believes that the state needs some sort of mechanism to control public access to protect the area's resources. However, we request that the bill contain specific language that ensures that access for Native Hawaiian traditional and customary purposes to the NAR will be protected.

In addition, we ask the DLNR to provide OHA notification on all public hearings on any proposed administrative rules relating to public access to the ÿÄhihi-Kïnaÿu NAR.



This plan seeks to sensitively prevent abuses of the area, which is the intent of Senate Bill 2739, while respecting the access rights to state lands south of the reserve and avoiding the problems with the Department's jurisdiction of the road.
- (2) Increased departmental presence with a new ranger position (total of 4) and a naturalist and volunteer program.
- (3) Newly implemented visiting hours.
- (4) The possible implementation of a two-year area closure plan.

Limiting public access to the NAR via the jurisdictional control of the paved is only one of several methods to control public access to these fragile resources. However, the drawback with controlling use through this road access is that the paved road also provides access to Dumps surfing area, private parcels and La Perouse Bay - which are not part of the NAR. The bay is currently open to the public and is used daily by visitors who want to see the historic monument and residents who fish, hike, swim and snorkel in the bay. The Makena-Keoneoio government road is also the only public access by land for those who wish to visit the Kanaio coast and the historic King's Trail and the private land holdings.



The County of Maui (County) constructed and has maintained and improved the road to provide access to local residences and the multitude of tourists to the NAR and La Perouse Bay. To turn the entire road from 'Polo Beach' near the Maui Prince Hotel to La Perouse Bay over to the Department would impose an unmanageable maintenance burden on the Department for which it does not have the manpower, expertise, equipment, or experience. This road currently services public and residential access.

There are other options the Department is pursuing to control access into the NAR, such as gating the parking areas. In addition, the Department is currently developing a management plan for the area including the NAR. This process can reach out to the community and county to discuss management options for the road. The Department believes this process will be able to find an approach that will advance the widespread public support of increasing protection of the reserve while providing the correct amount of public access to Dumps, the NAR, La Perouse Bay and the private land parcels without burdening the Department with maintenance costs of a heavily used public road.
