Aloha Committee Chair Herkes and Committee members.

I (a current mental health counselor in training) am writing to support the passage of SB 2159 HD1, by the full legislative body, and to offer testimony herein for supporting its passage.

I am a local (born and raised) Hilo, Hawai'i resident whose passion and career is at stake without the passing of this bill. Our isolated island and rural nature that de-selects for us among medical practitioners and health providers, massive cuts in the budgets and the general economic turndowns that ripple through human services first, and thus the need for wider coverage and ability to select among various options for the poorer members of our communities in particular.

Research suggests that when people see therapists beforehand, there is SIGNIFICANTLY LESS frequent number of visits to medical doctors in general, not just for mental health concerns, and thus a savings at those levels as well. More adequate numbers of Licensed Mental Health Practitioners providing counseling could prove to alleviate the high need for such services among rural Hawai'i communities due to increased population, returning veteran needs, overload on some already licensed providers, and the need to expand choice options for all recipients.

As a hopeful future local private mental health practitioner, I am also petitioning that the provision of insurance coverage vendorship at this time, along with the Sunset removal, will be a time and money saying means and practice for all professionals, insurers, government and for community members in need of services now and in the future. The University of Hawai'i at Hilo currently offers a counseling program, which grants more local residents an opportunity to secure a career as a professional in the helping field. Certainly the issue of training new therapists each year who can then earn a living is among the above concerns, but serving the larger public's general well-being is at the core of these concerns.

Thank you for the opportunity to present my support for the passage of SB 2159 HD1 (by the full legislative body) and for contributing to fulfilling my passion and dreams of being able to humbly serve the needs of my ohana!

The article further postulates of studies, on adults 26 years and older were in the highest category for needing treatment but not getting it......"

The same article also revisited a study which is consistent with other reports that show, "Hawaii has a relatively low suicide rate but higher Suicide rates for young people".
