Title:

S.B. 2235, Making an appropriation to provide for educational assistants.

Purpose:

To appropriate funds to provide one educational assistant for every

public school class in grades K-3.

Department's Position:

The Department of Education (Department) recognizes that educational assistants (EA) play a vital role in providing support to teachers and students in the classroom. However, while the Department supports the concept of having one EA in every classroom in grades K-3, there are concerns regarding this bill.

1. Annual Personnel Cost:

The number of additional EA positions required by this bill is 2,393. This is a 74% increase in the total number of existing EA positions (3,275) statewide with an annual salary cost of \$50,253,000.

2. Recruitment of EAs:

Currently, the Department has a shortage of EAs due to the additional requirements mandated by the No Child Left Behind (NCLB) Act. If the additional positions are temporary positions, this will add to the recruitment dilemma.

3. Training:

Due to the added requirements of NCLB, the Department would require additional funds to provide appropriate training for the additional 2,393 educational assistants. If EAs do not meet the basic requirements, the Department will need to emergency hire these employees. Emergency hire employees do not have the benefits as other contracted employees. This then becomes a recruitment and retention dilemma.

While the concept to have an EA in the K-3 classrooms is a positive measure, the priority must be given to the Board of Education's supplemental operating budget.

The Hawaii State Teachers Association supports SB 2235. Kindergarten to Grade 3 are crucial years in a child's education. It is during these years that they receive the foundation for reading and writing which are important for succeeding in the later years of education. It is also during these years that behavior problems occur more frequently due to maturity and developmental level of the students.

The Board of Education's policy on class size is 20:1 in Grades K-3 with the maximum not to exceed 25:1 in Grades K-2. There have been incidents of the latter occurring in classrooms where teachers have had their plates full with teaching the curriculum, correcting paperwork, and working with individual students. An educational assistant in every classroom grades K-3 will assist the teacher with student behavior problems. This will assist to provide the best quality education to the students.
