Chair Chun Oakland and Members of the Committee:

The Attorney General takes no position on the intent of this bill; however, there are legal flaws that will need to be corrected if it is to accomplish its intended purpose.

This measure seeks to give grants to four senior centers pursuant to chapter 42F, Hawaii Revised Statutes (HRS). Two changes are necessary to effectuate this purpose.

- 1. The definition of the term "grant" in section 42F-1, HRS, requires that the Legislature specify the organization to which the grant will be awarded. The bill must state the correct legal names of the entities to which the grants are to be awarded, not the name under which they may be doing business. For example, our research indicates that the Lanikila Multi-Purpose Senior Center is not an incorporated entity capable of entering into contracts in its own name, but instead, is operated by Catholic Charities Hawaii, which is a legal entity. The bill should specify that the grant be awarded to Catholic Charities Hawaii for the operation of the Lanikila Multi-Purpose Senior Center. Kapahulu Center, Moiliili Community Center, and Waikiki Community Center appear to be the correct, legally registered names of those entities.
- 2. Further, as a practical matter, the bill must specify the amount to be awarded to each recipient. This information is necessary for the expending agency to be able to properly contract with the recipients pursuant to section 42F-104, HRS. As the bill is currently drafted, it appears that the four organizations will have to split a total amount, and there is no indication of how that amount is to be divided.

PURPOSE: The purpose of S.B. 2347 is to appropriate funding for the operations of certain senior centers on Oahu that shall be expended by the Department of Human Services.

DEPARTMENT'S POSITION: While the Department of Human Services appreciates the intent of this bill to appropriate funding for senior centers that will provide our Kupuna with meaningful activities in support of a healthier lifestyle, the Department's opinion that the appropriation of these funds would be more effectively administered by the Executive Office on Aging (EOA) administratively attached to the Department of Health (DOH). After conferring with DOH, it is clear that the intent of this bill is consistent with Executive Office on Aging's goal to allow our Kupuna to remain active, healthy, and socially engaged in order to prevent premature disability and institutionalization.
