SB 2423, SD2 RELATING TO LAND ACQUISITION

Chair Ito and Members of the Committee:

Thank you for the opportunity to represent Governor Lingle on SB 2423, SD 2 in support of this measure that provides tools for the acquisition of lands at the area known as Turtle Bay on Oahu's North Shore. We appreciate the House scheduling this hearing to provide this legislative vehicle, should it be needed, for this significant undertaking.

Before discussing the specifics of SB 2423, SD 2, I would like to provide some history behind the Governor's State of the State Address when she introduced the idea that the State, in collaboration with private, public, and non-profit partners, should purchase the 850-acre Turtle Bay property. For several years the Lingle-Aiona Administration has been monitoring activities on the North Shore. Governor Lingle has long been troubled by the proposed development of a major resort complex in this area and the impact this would have both on the public infrastructure and the quality of life for Oahu residents and visitors.

She was encouraged last year by two significant purchases of land supported by the North Shore community. A coalition of community, public, and non-profit organizations came together to preserve the Waimea Valley and to purchase Pupukea-Paumalu. During her State of the State Address the Governor recognized several of the community leaders who were instrumental in these efforts.

When it was announced that the Turtle Bay creditors filed a foreclosure lawsuit against the Turtle Bay owners, Governor Lingle recognized this was the opportune time for

the State to publicly express its interest in preserving and protecting nearly five miles of pristine coastline and some of the last remaining open space along the North Shore.

The Legislature also has long recognized the significance of this area and in 2006 proposed House and Senate Resolutions calling for the rigorous reexamination of the expansion of the Turtle Bay Resort. While neither of the 2006 resolutions passed, in 2007 the Legislature enacted HCR 194 that requested the Senate Committee on Judiciary and Labor and the House Committee on Labor to convene a joint hearing on the impacts of the Turtle Bay Resort expansion on the vibrant North Shore of Oahu. Unfortunately, this joint hearing never took place.

In 2008 we have the opportunity to join together, Legislative and Executive branches, private and non-profit, community-based and national, federal and local, to save this unique and special place.

SB 2423 SD 2 is modeled along the lines of the successful Kukui Gardens legislation that allowed the preservation of affordable housing in downtown Honolulu. First, it provides unspecified sums for the Governor, or her designee, to negotiate with the current landowner, Oaktree Capital Management, and to enter into cooperative agreements with other entities to help acquire the property. Second, it further authorizes the issuance of an unspecified amount of general obligation bonds for the possible purchase of the property and provides that these bonds shall not lapse until June 30, 2010. And, it authorizes the use of eminent domain powers should an agreement not be reached.

While it may not be necessary to use these legislative tools to acquire this property, this bill provides an avenue should non-legislative solutions not succeed.

We are concerned that the description of the properties in Section 2 of the bill limits the State's ability to acquire the resort and accompanying developed portions held by Kuilima Resorts LLC. Governor Lingle has made it clear that the State does not intend to operate a hotel or manage condominiums and golf courses. However, it is necessary and prudent for the State to have the ability to acquire both the improved and unimproved lands. We recommend Section 2 and each reference in the bill to "unimproved lands" be revised to state "improved and unimproved lands."

We also suggest that the language in Section 6 be amended to allow the use of private investment or donations, federal funds, special funds, public lands, and other assets both to carry out the negotiations as well as to acquire Turtle Bay. Governor Lingle has been encouraged by the outpouring of support she has received from a wide variety of organizations and entities who want to help in this endeavor. Recently, Governor Lingle met with Secretary Dirk Kempthorne about federal assistance from the Department of the Interior. We have also been encouraged by support from charitable organizations, including the Trust for Public Lands. We ask that this legislation, if it is enacted, allow for the maximum flexibility in how resources are brought to this project.

Some have voiced concerns that Governor Lingle has not presented a specific plan to purchase the land or describe what will be done with the property. That is true because she recognizes it should not be her plan, but the community's plan. As a first step in shaping this vision, Governor Lingle held a "Talk Story" on March 4th with over 500 members of the community to hear their thoughts and ideas on this proposal.

This proposal touches our entire State and requires discussion and input from all sectors. The Governor has just announced the formation of an Advisory Working Group to help serve as a communications channel for this effort. As stated on prior occasions, the Governor will not negotiate this transaction through the media. Additionally, the Governor has had a long-standing policy of preferring to negotiate land transfers rather than exercising eminent domain powers.

In summary, for too long and too often important pieces of rural Hawaii have been sold to the highest bidder and developed into something that forever changed the essence and character of the area. Governor Lingle has spoken often and eloquently about the need to transform our economy into one that no longer depends upon the sale of land, to one based on the brainpower of our residents. As we work on this transformation, it is crucial to preserve elements of Hawaii's lifestyle and identity. Preserving Turtle Bay is an important part of this effort. We look forward to working with the Legislature, members of the public, federal agencies, national organizations, and even international organizations to pursue the truly worthy goal of preserving Turtle Bay.

Aloha Chairperson Ito and Vice-Chair Karamatsu:

The Trust for Public Land (TPL) supports the intent of SB 2423, S.D. 2 Relating to Land Acquisition, which proposes to allocate funds towards the acquisition of the Turtle Bay Hotel and Resort and its accompanying undeveloped lands (inclusive of the mauka parcels), but has the following concern. TPL's mission is to support voluntary land conservation, and cannot support efforts to condemn the property against the landowner's wishes.

TPL conserves land for people to enjoy as parks, gardens and other natural places, ensuring livable communities for generations to come. Nationwide, TPL has five program initiatives: (1) providing parks for people, (2) protecting working lands (farms, ranches, and forests), (3) conserving natural lands (wilderness, wildlife habitat), (4) safeguarding heritage lands (cultural and historical resources), and (5) preserving land to ensure clean drinking water and the natural beauty of our coasts and waterways. In Hawai'i, TPL has worked with public and private partners to conserve over 36,000 acres of land in the State, including Pūpūkea-Paumalū and Waimea Valley on O'ahu, Wao Kele o Puna on Hawai'i Island, Mū'olea Point on Maui, and Lumaha'i Beach on Kaua'i.

First, TPL was as surprised as the Legislature by the Governor's State of the State address and the announcement of an initiative to acquire the Turtle Bay Resort. Nonetheless, we support the bold initiative, and believe that by working in partnership with the Legislature, federal agencies, our Congressional delegation, the community, the business community, and private donors, we can together, achieve our vision of preserving the unique rural character of North Shore, and at the same time, enhancing much needed jobs provided at the existing resort and golf courses.

Second, as it has done with other undeveloped conservation lands (e.g., Moanalua Valley, Pūpūkea-Paumalū), the Legislature can appropriate seed money that can be leveraged against other federal, county and private sources of funding for conservation acquisitions. To the extent that any of the undeveloped lands qualified for Legacy Lands Funds, those parcels could compete with other parcels for the limited Legacy Lands Funds (about \$4.7 million per year) among other projects.

Third, TPL also supports authorizing the Governor to acquire the developed portions of the resort to give her maximum flexibility.

TPL supports SB 2423 SD2 with the comments/concerns, and is ready to assist the State and other conservation partners in collaborative efforts to make this acquisition happen.

The Ko'olauloa-North Shore Alliance is a network of 25 organizations who support the initiative to preserve the undeveloped lands mauka and makai of the Turtle Bay Resort. We applaud the Legislature for understanding the importance of moving this bill forward to provide options in this complicated, but attainable effort.

If the State fails to act now that the property is being foreclosed, it might be possible for another developer to come along and build 3500 more resort units 22 years from now, still based on the 1986 approval. The community does not want massive resort expansion and urbanization of the North Shore.

Two-lane Kamehameha Highway cannot support the current volume of traffic, let alone thousands of new cars the expanded resort would generate. Failing to act now may obligate the State to invest billions of dollars later for a new highway to an area that will no longer be rural.

Looking back years from now, people will realize that preserving these lands at Kawela Bay, Kuilima and Kahuku Point was a bargain. Please pass SB 2423 SD2.

TESTIMONY IN SUPPORT OF SB 2423 SD2

Chair Ito and members of the Committee:

The Sierra Club, Hawai`i Chapter, with 5500 dues paying members statewide, supports SB 2423 SD2, exploring dedicated funding approaches to protect the Turtle Bay area in perpetuity. We appreciate the multi-pronged approach to accomplishing this objective that SB 2423 SD2 offers.

As you may know, the Sierra Club is a co-plaintiff in a lawsuit seeking to require a Supplemental Environmental Impact Statement for the proposed resort expansion at Kawela Bay and Turtle Bay Resort. The litigation stems from the massive development planned for Turtle Bay Resort on the North Shore of Oʻahu by Kuilima. The project contemplates the expansion of the Turtle Bay Resort to some five times its existing size to approximately 3500 total hotel and condominium units. The Sierra Club joins Keep the North Shore Country in its concerns that the Kawela Bay Project—now being undertaken nearly 25 years after the original environmental review was completed—will have significant impacts and cumulative environmental effects which have not been properly evaluated or considered by the County or the developer.

The Turtle Bay area contains breathtaking coastline, sensitive wetland environments, and endangered species habitats. It is a playground for Hawai'i residents as well as visitors. It is also a good area for fishing on the North Shore—but accessibility through the existing "private property" has been raised as a concern. Protecting the Turtle Bay area in perpetuity would serve current and future generations well.

The luxury units being planned for Turtle Bay would be way too expensive for most local people and would accelerate the high cost of housing. Local families who have lived in Ko'olau Loa for generations

would be displaced. In addition, Water recourses, Watershed capacity and other infrastructure would be severally affected.

PRESERVE CURRENT JOBS in TOURISM, PRO-GOLF & our FILM INDUSTRIES:

Scenic Turtle Bay and Kawela bays are vitally important for our Tourist, Golf and Film Industries-and <u>preserving the current jobs</u> in these industries.. Pro-Golf in Hawaii is also already in jeopardy. Saving Turtle Bay is not just a "nice thing" for local people, it is crucial for keeping Hawaii as a World Class Tourist & Golf destination.

Already in the recent issue of National Geographic's travel magazine said that Oahu is already "in serious trouble" as a vacation destination" because of the overcrowding

In addition, our Film & TV Industry uses the spectacular nature on the North Shore as a backdrop, would be severely damaged. Many TV and Movies are filmed at Turtle Bay, using the pristine beaches as their setting. If these beaches were developed, the Film Industry would move to Thailand, and Hawaii would loose those high-quality, interesting films jobs.

PROTECT HAWAII'S ENDANGERED SPEICIES:

The pristine beach at Turtle Bay is a Birthing-Area for our Endangered Monk Seals. Hawaii has more Endangered Species per square mile than any other place in the world. The Hawaiian Monk Seal is one of the world's most endangered species. There are an estimated 1200 Hawaiian Monk Seals, but their numbers are declining.

Our Monk Seal "N7" gave birth and nursed her pup in safety for 54 days at Turtle Bay. If the unique protected shallow inlet at Turtle Bay were overrun with thousands of tourists, our monk seals would have to choose another spot along Oahu's well-developed shore, and nurse their pups further out in a less protected, more dangerous area.

Endangered Hawaiian Green Sea Turtles are also frequently spotted at the bays. There has also been some speculation that there are Endangered Sea Turtle nests at Turtle Bay. Sea Turtles' nests in the sandy areas are very fragile. If there were thousand of tourists tromping on the beaches, the nests would not survive.

PRESERVE the NATURAL BEAUTY OF HAWAII for FUTURE GENERATIONS:

The beauty of Ko'olau Loa and the North Shore, our beaches and wildlife should be preserved for both local people and visitors to come and enjoy for generations.
