## RE: S.B. 2425; RELATING TO ARSON.

Chair Taniguchi and members of the Senate Committee on Judiciary and Labor, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in support of Senate Bill 2425.

The purpose of this bill is to clarify what costs are included in the mandate that the defendant pay costs associated with extinguishing a fire which results in damage to ten thousand square feet or more of property.

We support the passage of S.B. 2425; currently as written, the statute mandates that a defendant pay costs associated with extinguishing a fire which results in damage to ten thousand square feet or more of property but does not give any guidance to the court as to what costs can be included. For example, are personnel costs such as salaries and benefits of fire personnel fighting the fire included? Or are those costs excluded because they would have to be paid irrespective of whether the fire occurred?

We would prefer guidance be given in the statute to minimize confusion and possible appeals on the subject and for this reason, we support the passage of S.B. 2425.

I am Kenneth G. Silva, Fire Chief of the Honolulu Fire Department (HFD). The HFD supports S.B. 2425, which specifies the fire fighting costs that a defendant convicted of arson may be required to reimburse.

Intentionally set wildland fires continue to tax the resources of county, federal, and state fire departments and critically lower fire protection coverage in other areas of a community. This bill seeks to specify the reimbursable costs of fire extinguishment for those convicted of arson crimes and may serve as a strong deterrent for such actions. Prosecutors and judges will then be clear as to what fire fighting costs are eligible when restitution is deemed appropriate.

Costs incurred by the HFD for two wildland arson cases were \$3,000 for a fire in Village Park and \$11,000 for a fire at the Central Oahu Regional Park. Since no suspects were apprehended for a wildland fire in Waialua last year, no cost estimates were calculated.

The HFD requests your committee's support on the passage of S.B. 2425.

RE: S.B. 2425: Relating To Arson

Chair Taniguchi and Members of the Committee:

This measure would permit the court to order a person convicted of setting a brush fire to pay for the attendant costs of extinguishing the fire, including salary, supplies and meals.

The Office of the Public Defender opposes S.B. 2425.

While the settings of brush fires are destructive and costly events, these offenses are generally committed by minors, who are rarely caught and prosecuted. In reality, very few people would be able to afford to pay for the cost of extinguishing a brush fire. While it seemingly makes sense to have those individuals prosecuted for their crimes pay directly for the consequences of their actions, we believe that this sets a bad precedent. Our fire and police departments are already funded by the government. Individuals should not be made to "pay" for the cost of providing public services such as fire and police protection.

We do not believe that this bill will have any deterrent effect, as the perpetrators of these offenses are too immature to think about the consequences of their actions.

We oppose S.B. 2425. Thank you for the opportunity to comment on this bill.
