MAKING AN APPROPRIATION FOR THE HAWAII CAPITAL CULTURAL DISTRICT

Senate Bill No. 2583 appropriates an unspecified amount of general revenues to renovate the Kamamalu Building and renames the No. 1 Capitol District Building to the Hawaii State Art Museum for exclusive use by the museum. The bill further requires the State agencies in No. 1 Capitol District Building (a.k.a. Hemmeter building) to relocate to the renovated Kamamalu building.

We are opposed to this bill.

The exclusive use of the No. 1 Capitol District Building by the Hawaii State Art Museum may not be the best use of this centrally located office building. Rather than relocating the existing tenants of the No. 1 Capitol District Building to the Kamamalu Building, priority should be given to relocating agencies that are now leasing office space which would reduce the operating expenses of the State.

Further, the No. 1 Capitol District Building was acquired by the State using tax exempt financing. Therefore, commercial use of the building must be limited to protect the tax exemption.

We have a concern as to whether it is prudent to expend the State's financial commitment at a time when we are facing a moderation in revenue growth. The initial renovation of Kamamalu Building is currently underway for removal of asbestos/hazardous materials and the interior demolition of flooring, ceilings, partitions, electrical, plumbing, and air conditioning system. To complete the renovation for occupancy by State departments will costs an additional \$28 million in general obligation bonds.

Chair Fukunaga and members of the committee, thank you for the opportunity to testify before you on S. B. 2583.

The State Foundation on Culture and the Arts (SFCA) defers to the testimony of the Department of Accounting and General Services regarding the feasibility of renovating the Kamamalu Building.

The Hawaii State Art Museum (HiSAM) currently occupies

12,000 square feet – three galleries - in the No. 1 Capitol District

Building. Amenities include an extensively used Multipurpose Room, a volunteer resource room, a small kitchenette, and leased spaces for the Downtown @ the HiSAM café and museum gift shop.

After five productive years, HiSAM has developed beyond the founding vision for the museum. Growing pains include inadequate room for ongoing workshops, docent training, and expansion of amenities for the Visitor's Center. The storage areas for the café and gift shop are nonexistent, unfortunately not part of the original planning and staffing needed for more programming and facilities management cannot be

Ideally, HiSAM would house permanent display(s) of stellar works of art primarily by local artists that would serve to symbolize the State Collection's public image, identity and importance. These permanent display(s) would in turn be complimented by rotating exhibits designed to feature themes, specific artists, cultural works, and displays pertinent to community development.

This was the intent of the Warnecke Plan, also referred to as the "Hawaii State Capitol Civic Center Master Plan," approved by Governor Burns and Mayor Blaisdell. The plan envisioned the Capitol District as a cultural center for residents and visitors, as well as the seat of State government. Extending the breadth of the museum's programming, as well as its physical presence beside the State Capitol, will further enhance the Capitol District as a cultural tourism destination for visitors and a historical and educational center for residents, particularly Hawaii's youth.

We do confirm the need for added space to grow and develop the Hawaii State

Art Museum, its programs, staffing, and importance in reflecting the richness of

Hawaii's people, cultures, and artistic accomplishments. With regard to the allocation of

state agency space assignments, the SFCA defers to the Comptroller and the Public

Works Division as having the authority to make those decisions.

It is awesome, creative beautiful, but crammed three and four pictures deep into a back corner of the Hawaii State Art Museum. Many of the pieces will go on to represent Hawaii in National competitions. To get to The 45th Hawaii Regional Scholastic Art Award 2008 display you must walk through a tiny portion of the thousands of fine works by Hawaii's artists that are packed away out of sight because there is not enough room to adequately display our fine collection. HiSam could much better bless Hawaii's people by having all of Capital #1 building for their use.

What great civilization, ethnic group, or country is not known by its arts? What is Hawaii without hula and slack key? Yet "No child left behind" is squeezing music, drama, and graphic arts from the public school curriculum. When there is less and less public education money for the arts, HiSam needs to step in with teaching space, theater space, more display space and adequate staff to serve the needs of Hawaii's people so that they can learn and be touched and inspired by the arts. Emperors, kings and barons once sponsored and patronized the great artist's whose works we still appreciate, in a democracy such encouragement needs to be egalitarian and nurtured through wise governance. Please support SB 25 83.

The Windward Artists Guild, organized in 1960 regularly sponsored an Easter Arts Festival at Ala Moana Center. That venue has long since closed because of commercial pressures. At one time the new AMFAC building, in order to get a special variance, agreed to dedicate a large beautiful space on the ground floor as a public art venue. Some how that space is again lost to organizations like WAG due to commercial pressure. Now the Art Academy is squeezing down it Artists of Hawaii venue, again making it difficult for the emerging artists of Hawaii to have a place to show their work. The Windward Artists Guild, many of whose artists are represented in Hawaii's art museums, is a non profit volunteer organization and these days at best finds meager places to display its work, though we have few starving artists because most have other jobs to pay their bills. What they lack is a place for the public to be inspired by their creations. HiSam needs a space like that of the Art Academy at Linekona for local organizations to constantly put before our Hawaii citizens the creative arts of our people.

My name is Peter Rosegg and I am a commissioner for Oahu on the Hawaii State Foundation on Culture & the Arts and I am the chair of the committee of the commission which overseas the Arts in Public Places program and the Hawaii State Art Museum.

S.B. 2583 requests funds to renovate the Kamamalu Building so that the No. 1 State Capitol District Building can be used exclusively for the Hawaii State Art Museum.

I am in strong support of this bill and urge you to give it your approval. First, the Kamamalu Building has long stood empty, of no service to the people of Hawaii. It occupies prime real estate downtown, close to the business community, many government agencies and the Capitol.

Second, the Hawaii State Art Museum has shown itself to be a valuable part of the downtown scene and important to the cultural and arts community and of interest to many visitors who come to Hawaii to enjoy its cultural offerings. With more space it could do more, offering a real culture and arts center houses diverse activities that would benefit the Hawaii community and draw visitors to downtown and its many cultural and historic attractions.

The first step in making this happen, clearly, is to renovate Kamamalu so agencies can begin the process of moving out of the No. 1 State Capitol District Building and so the Hawaii State Art Museum can begin its expansion. It will not all happen at once, but your support is essential to beginning the process.

I am writing in support of SB 2583. I currently serve as President of the Friends of the Hawaii State Art Museum.

I believe there are four important reasons to enact this bill.

- 1. The potential economic and cultural benefit to the State of Hawaii. We have the ability to brand Hawaii as an art destination for visitors. They can learn from, enjoy and acquire world class art from artists of Hawaii. Many of our artists are collected by the finest museums in the United States. The Guggenheim Museum in New York, the Whitney Museum in New York, and the Yale University Art Gallery in New Haven, all have artists from Hawaii in their collections. The present size of our museum is not large enough to create a brand for the Hawaii artists community and to create another visitor industry. The state also owns many pieces now in storage that could easily be displayed in an expanded museum. The Hawaii art industry is vibrant and alive. The state has an opportunity to create a venue to take advantage of something that is already here and only needs to be exposed and branded to add another reason for tourists to come to Hawaii and learn about our culture and add to our economic base.
- 2. There is <u>nominal cost</u> to create this new visitor industry brand compared to creating the infrastructure for potential new industries. The state already owns all the real estate and art needed to create the expanded museum. Our 1% art law enables the state to acquire many more pieces than can be shown through the Art in Public Places program and the museum. In fact showing this art collection was the original basis for the Museum. Now we have the opportunity to show many more works in a building we already own and to move non-museum departments to another building we currently own.
- 3. The <u>educational value</u> of an expanded museum to the people of Hawaii and our visitors. A larger museum has the ability to tell the history and evolution of Hawaii through the eyes of our artists. They not only portray their views of our incredible natural beauty, but they tell the story of our changing society. An expanded museum would enable us to tell a more complete story to demonstrate our unique culture.
- 4. The <u>ability to keep our best and brightest</u> artists in the islands. With a branded art industry, our artists would not need to move to the mainland to support themselves in their chosen career. Our artists could pursue their creative talents while staying in Hawaii.

The Department of Accounting and General Services (DAGS) opposes this bill because it is premature. Current estimates for renovating the Kamamalu Building exceed \$30 million. As a result DAGS is undertaking a review of the project. DAGS hopes to look at alternatives to renovating the building and hopes to have a recommended course of action by the 2009 Legislative Session.

It may be uneconomical and impractical to renovate the Kamamalu Building for State use, and transferring it to the State Foundation on Culture and the Arts is a decision that cannot be made at this time.

DAGS recommends that this bill be held.

My name is Donald K. Johnson and I am 100% in SUPPORT of Senate Bill 2583.

After this hearing walk across to Capital District #1 and view the artwork by Hawaii's middle and high school youth now on display. It is awesome, creative beautiful, but crammed three and four pictures deep into a back corner of the Hawaii State Art Museum. Many of the pieces will go on to represent Hawaii in National competitions. To get to The 45th Hawaii Regional Scholastic Art Award 2008 display you must walk through a tiny portion of the thousands of fine works by Hawaii's artists that are packed away out of sight because there is not enough room to adequately display our fine collection. HiSam could much better bless Hawaii's people by having all of Capital #1 building for their use.

What great civilization, ethnic group, or country is not known by its arts? What is Hawaii without hula and slack key? Yet "No child left behind" is squeezing music, drama, and graphic arts from the public school curriculum. When there is less and less public education money for the arts, HiSam needs to step in with teaching space, theater space, more display space and adequate staff to serve the needs of Hawaii's people so that they can learn and be touched and inspired by the arts. Emperors, kings and barons once sponsored and patronized the great artist's whose works we still appreciate, in a democracy such encouragement needs to be egalitarian and nurtured through wise governance. Please support SB 25 83.

The Windward Artists Guild, organized in 1960 regularly sponsored an Easter Arts Festival at Ala Moana Center. That venue has long since closed because of commercial pressures. At one time the new AMFAC building, in order to get a special variance, agreed to dedicate a large beautiful space on the ground floor as a public art venue. Some how that space is again lost to organizations like WAG due to commercial pressure. Now the Art Academy is squeezing down it Artists of Hawaii venue, again making it difficult for the emerging artists of Hawaii to have a place to show their work. The Windward Artists Guild, many of whose artists are represented in Hawaii's art museums, is a non profit volunteer organization and these days at best finds meager places to display its work, though we have few starving artists because most have other jobs to pay their bills. What they lack is a place for the public to be inspired by their creations. HiSam needs a space like that of the Art Academy at Linekona for local organizations to constantly put before our Hawaii citizens the creative arts of our people.
