Title: S.B. 2728, Relating to the Hawaiian Language
Immersion Program

Purpose: Appropriates funds for teaching positions at schools with Hawaiian language immersion programs, where supplemental teaching positions are most needed.

Department's Position: The Department of Education (DOE) supports this bill to provide supplemental off-ratio positions to schools whose enrollment may not warrant a regular position based on the weighted student formula as defined by Act 51. These supplemental positions will provide the needed support for Hawaiian Language Immersion Program teachers who teach multiple grade levels and multiple content areas. However, these positions should not supplant the positions the school is required to provide the program based on student enrollment. While the DOE supports the appropriation, it should not replace the current Board of Education budget priorities.

As the principal of a school with a Hawaiian Immersion program, I support SB2728 which proposes to provide funds at teaching positions at schools with Hawaiian language immersion programs, where these positions are most needed.

The current DOE funding formula that provides a teacher for every 27 students does not work for the Hawaiian Immersion program. Many of these programs aren't large enough to secure enough teachers to provide instruction in the variety of content areas necessary. At Kahuku, our Hawaiian Immersion teachers are teaching six grade levels (grades 7-12) and most subject areas. It's difficult for teachers to be highly qualified in multiple subject areas.

Aloha Chairpersons Sakamoto and Tokuda and honorable members of the committees. I am Clyde Namuo, Administrator to the Office of Hawaiian Affairs (OHA).

OHA is in **strong support of SB 2728** which seeks to establish full-time teacher positions at kula kaiapuni, schools with Hawaiian language immersion programs. Additional teaching positions are the most needed in rural and outer-island Kula Kaiapuni schools where off-ratio positions are often needed to supplement those schools' regular allocation from the weighted student formula as defined by Act 51, Session Laws of Hawai'i 2004. The schools with Hawaiian Language Immersion Programs needing off-ratio teacher positions are Waimea Elementary School, Molokai Middle School, Molokai High School, Kahuku Intermediate School, and Kahuku High School.

Kula Kaiapuni celebrates two decades of growth, expansion and success this month. Since its inception, funding for teacher positions has always been a key strategy to ensure the growth and vibrancy of the Department of Education's Hawaiian Language Immersion program, and, as a result, contributed to the vibrancy and growth of the language and culture of our Native Hawaiian people once near the brink of extinction. The success of the program is admired nationally and internationally but much of this success is due to the commitment and diligence of 'ohana as well as the hard work of kumu or teachers. This Legislative body has consistently supported the Hawaiian Language Immersion Program over the past twenty years, seeing it as a crucial vehicle in carrying out the provisions of article X, section 4, and article XV, section 4, of the Constitution of the State of Hawai'i and provisions of Act 133, Session Laws of Hawai'i 2004, and Act 159, Session Laws of Hawai'i 2005. The Hawaiian language immersion program continues to play a central role in the perpetuation of Hawaiian culture, history, language, values, and practices as provided for by the Constitution of the State of Hawai'i.

The Office of Hawaiian Affairs shares the same constitutional mandates to perpetuate the language, culture, and history of our kūpuna and therefore fully supports this bill. Again, OHA supports SB 2728 and we urge you to pass this measure. Mahalo nui loa.

Chair Sakamoto and Members of the Committee:

Aloha! My name is Shannon Ku'uipo Garan and I am a former kumu at Ke Kula 'o 'Ehunuikaimalino in Kealakekua on the Island of Hawai'i. Because language expresses the soul of a culture, I strongly support SB 2728 and would like to commend the Legislature's recognition of the importance of revitalizing, maintaining, and strengthening the Hawaiian language.,.

In the nine years I taught in an immersion school, I experienced the struggles and hardships that still continue today for many, if not all, immersion schools. There were years where we were not able to have a single class grade assigned to a teacher. As our school grew, the need for teachers became greater, but difficult to fill. Grades were eventually split and/or combined in order to accommodate the students who wanted to learn in the medium of the Hawaiian language. As difficult as it was, the teachers did what they did best, educating the students to love, not only the Hawaiian language, but our culture as well. Yes, I am no longer an immersion kumu, but still strongly support those who are. My nine year old son has been attending immersion school since Kindergarten and continues to attend immersion classes at Waiau Elementary.

I would hope that this bill will be the catalyst that will create more teacher positions not just to certain immersion schools but to all immersion schools. E ola ka 'olelo Hawai'i!

I strongly urge the committee to pass this bill.

Aloha Kākou. My name is Ione Kamaka'a'ohua Sproat Kamaka'ala, currently an eleventh grade student in the Hawaiian Immersion Program at Kahuku High School. I am in support of the Senate Bill 2728. There are five academic school grades at Kahuku, ranging from seventh grade to eleventh. We, along with other immersion schools, lack the teaching positions needed to educate the students to their highest ability.

There are two full time teachers that are present for the entire school day, and there are two part time teachers. We love to learn new things, but there are times when there are not enough teachers around to help us. If we do somehow get another teacher, then it would benefit us as students and we would learn more than we are currently learning.

This coming school year, 2008-2009, there will be six grades rather than five, and there will be more students in the class. There is not enough help for all of us as it is right now, so when our class size grows, it will become a bigger problem to us as the students, the teachers, and possibly even to the parents. But if we had enough teacher positions to be filled for our Looping classes, then it would go to helping the students achieve more and accomplish greater academic goals in the classroom.

In every class, there are students with different levels of understandings. There are some students that are quick to respond and understand the assignments faster than most, and there are other students who do not comprehend as quick and accurate. It is difficult to teach children with different levels of understanding, especially when there are three grades learning different things in one classroom with one teacher. There should be another position opening to fulfill the needs of every student. By passing this bill, it would be the backbone support of fulfilling the No Child Left Behind law.

Next school year there is only one teaching position for the entire program that will run from grades seven to twelve, thus being six grade levels taught by a single teacher.
