Two of my children graduated from the Hawaiian Immersion Program, my son Ka'imikaua, in 2005 and daughter Lei'llimalani, in 2006. It was a struggle raising funds in Punana Leo, Kualalpu'u Elementary, Moloka'i Intermediate and now Moloka'i High School. My baby Ka'ena will be the third to graduate in the Hawaiian Immersion program 2008 and I am thankful that we have dedicated teachers like Kumu Manuwai and Kumu Mahinahou who faithfully took this long and exciting journey of perpetuating the language and culture of Hawai'i with my children.

In 2000-2001, the Hawaiian Immersion Program began with two full-time Intermediate teachers, Kumu Manuwai Peters and Kumu Mahinahou Ross. As the program expanded we were in need of another full-time teacher position to help accommodate the High School students. In 2005-2006, the DOE gave us the option to hire a new teacher and it was very slim because of lack of funds. Our parents held a meeting with the principal and vice principal, to request for another full-time Immersion teacher. Kumu Mahinahou was given the option to teach Science part-time in an English environment and part-time as a Science teacher for our Hawaiian Immersion Program however; he gave up his full-time Hawaiian Immersion position in order for the DOE to hire Kumu Kuoha as a full-time Intermediate teacher with the program.

Presently, Kumu Manuwai is the only full-time Hawaiian Immersion teacher in the High School level who does lessons plans for students in the 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> and 12<sup>th</sup> grade. Kumu Mahinahou continues to work part-time as a High School Immersion Science teacher also teaching 9<sup>th</sup>, 10<sup>th</sup> 11<sup>th</sup> & 12 grade and Kumu Kuoha is the full-time Immersion teacher for 7<sup>th</sup> and 8<sup>th</sup> grade students. We are in dire need of a full-time position for Kumu Mahinahou, and it's way over due on the part of the DOE because every year is the same old story, "No Funds."

In closing, twenty years have passed and I'm proud to say that my children and I have had the most loving, caring, and professional educational experience with Kumu Manuwai and Kumu Mahinahou and I support S.B. 2728 to provide off ratio teaching positions to help our teachers further their knowledge of teaching future generations that are committed to learning the Hawaiian Language and Culture of Hawai'i.

The teachers have also been informed by their principal that there will be combo classes next year.

My concern is the work overload for our teachers and the desire for our children to have the highest quality of education they can receive for the whole year. This is what I am requesting for the advancement of our keiki:

- 1. No more combo classes
- 2. One teacher per grade level
- 3. More time for teachers to collaborate in the Hawaiian Language Immersion Program (HLIP).
- 4. SPED services

Each grade level is not the same as the one above or below it. The standards and benchmarks are very different.
