**PURPOSE**: The purpose of S.B. 2730, S.D. 2, H.D. 1, is to establish a preference for placement of children needing child protective services.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) strongly supports this bill. This bill seeks to acknowledge appropriate relatives, who are willing and able to care for a child, as a preferred placement for a child who is in need of out-of-home care pursuant to chapter 587, Hawaii Revised Statutes (HRS). The proposed change is consistent with national trend, Federal law and child welfare best practices to ensure that children in State's custody are provided with the opportunity to stay within their family, whenever safe and appropriate.

S.B. 2730, S.D. 2, H.D. 1, is a collaborative effort that incorporates the concerns and input from several parties and AN EQUAL OPPORTUNITY AGENCY

represents the consensus of many, including but not limited to, the Office of Hawaiian Affairs, Legal Aid Society of Hawaii, American Civil Liberties Union, and the Department of the Attorney General.

Specifying appropriate relatives as a preferred placement does not mean that children who need out-of-home placement will automatically be placed with appropriate relatives. The safety of the child is paramount and consideration of the child's safety is the most important part of any placement decision.

Children under the placement responsibility of the

Department can only be placed into homes that meet foster home

licensing requirements. The Department has been increasing

capacity to provide support services and training to foster

parents through our contract with Hui Ho'omalu. Relatives would

have access to all supportive services available for foster

parents.

Appropriate relatives are a very special and integral part of the natural support system for a family. Placing a child with appropriate relatives will have positive effects and improve stability for the child. It helps to ensure that, when safe, the child can stay within the family system and sustain family and sibling relationships that support the child's safety, permanence and well-being and connection with family culture and heritage. In addition to simply being family, appropriate relatives often bring other strengths and resources, including additional life experience and maturity that benefit the child.

#### Dear Chairman Waters:

I'm a Program Director with Catholic Charities Hawai'i (CCH), a non-profit agency that has been providing social services in Hawai'i for over 60 years. CCH is also one of the partner agencies representing Hui Ho'omalu, which is a statewide collaboration composed of various community and faith-based agencies working together in partnership to address the needs of Hawaii's children in foster care.

Catholic Charities Hawai'i works closely with the Department of Human Services - Child Welfare Services focusing on Child Specific foster/resource families including Special Licensed Relatives (SLR). A great majority of the foster/resource families we serve are grandparents. This is also a reflection of our State, which has a higher percentage of grandparents and relatives raising children compared to the national average.

Kinship connection has been proven to be an important factor for foster children to thrive in their home environment. According to DHS, In 2005 alone, eleven states created or revised provisions of their state law relating to relative placement for abused or neglected children. Allowing grandparents and relatives to be the first priority for out-of-home placement is a culturally sensitive and sound idea that can only bring a stronger support system for Hawaii's foster children. We would also like to urge you to include the amendments as proposed by DHS to include the following:

- 1) Extending the Ohana preference to Grandparents and Relatives
- 2) Strongly support the identification effort/preference to the upfront work with Child Welfare Services

Again, <u>Catholic Charities Hawai'i strongly support(s)</u> Senate <u>Bill 2730</u> to give preference to grandparents and relatives for out-of-home placement of children needing child protective services.

I stand by my written testimony in support of Senate Bill 2730. I work at EPIC as the Ohana Connections Program Manager. As part of our program, we work with youth who are about to exit the foster care system due to reaching the age of majority. These youth do not have adoptive parents or legal guardians. They have longed to know their birth family and have often run from their foster homes to find their birth families. Or, they wait until they reach the age of majority to search for their birth families on their own.

I believe that it is important for grandparents and other relatives to participate in child protective hearings and to be given preference for out of home placements of children needing child protective services. Staying connected to birth family gives a person a profound sense of identity and belonging that those of us who have not experienced being disconnected will never fully understand.

I recently helped a young man who was in foster care from the age of 5 years until he reached the age of majority. He lived in 10 foster homes. He told us that he felt "empty and lonely" in foster care. Without knowing his family, he said he had "no self" and felt like a "blank". He said, "Without family, I didn't feel like I existed" and had "nothing to look forward to". He wanted "to find out who he was, why he was in foster care." He appreciated the State of Hawaii for providing money for clothes and food and for finding homes for him; yet he felt "weird and empty. He said he didn't feel loved, just protected."

This young man had lost touch with all of his family members. He wanted to know where his family so he could learn why he entered the system. We helped him find his family, and he told us, "Until I found them, I wanted to be alone. It was hard growing up not knowing them. He told us, "It's important to know your family and keep connections so you can turn to them in case you need support. It helps as you grow older so someone can look out for you in case a disaster happens."

When this youth met his family after so many years of not knowing where they were, he felt excited and also anxious. He didn't know how to behave with them, what they expected from him. In his words, he said "Finding them is easy. Bonding is harder. You have to know what to say, when to say it, and know what and when to do it."

From the relatives' side, they were angry when I spoke with them. They felt that there were barriers to stay involved with their young family member. After connecting with him after so many years, it has not been easy for them as they expected him to fit right in and to know how the family interacts.

By hearing the words of someone who has experienced being deprived of this family connection, I hope that you will better understand the importance that being with birth family means to children and will pass this bill on behalf of all children in the foster care system.

I work at Epic Ohana Conferencing as an Ohana Engagement Specialist. My job is to locate family members for foster youth who are about to age out of the system. The majority of the youth I work with have little or no contact with their biological family and haven't for years. They feel disadvantaged in many ways, yet the pressure on them to "make it" is high. They're like saplings without any roots which are expected to grow into trees. It's a daunting task.

It's also a task that will be made much easier if SB2730 is passed. The involvement of grandparents and other ohana from the very beginning of the foster care process promises to preserve the children's roots, which in turn gives them a sense of security and identity. That solid base, that feeling of belonging, is invaluable to children who have experienced abuse and upheaval.

Grandparents and the extended ohana deserve all the moral and financial support we can give them. Keeping children safe is the highest priority, but we shouldn't stop there. Identifying healthy family members who are able to provide a loving home, is a way to honor and respect the existing attachments the children have with the people in their lives. Inviting the grandparents and extended family to be a party in court hearings is crucial. Just because the parents have failed, doesn't mean the rest of the family has. Staying connected with family, to whatever degree possible, can give these kids the emotional nutrients they need to thrive.

According to a Hawaii CPSS report of 2005, children placed in out of home care over 12 months maintain a higher stability rate with kin than non-kin. In national studies, children living with family foster parents score better on physical, cognitive, and skill-based tests than those in non-family foster care. While there will always be those amazing, exceptional youth who make it no matter what, I think it's safe to say, for most of us, it's our roots that have fed our successes.

The Legal Aid Society of Hawaii hereby provides testimony to the House Committee on the Judiciary on SB2730 SD2 HD1 - Relating to Child Protection.

The Legal Aid Society of Hawaii is the largest non-profit provider for direct civil legal services in the State. Further, since 1996, we have assisted over 2,000 children as guardian ad litem on Oahu, Kauai, Maui, Hawai'i, Moloka'i and Lāna'i. We also represent parents on Kauai, Maui, Hawai'i, Moloka'i and Lāna'i and have represented kinship caregivers, including grandparents, throughout the state. Of many of the stakeholders involved in this conversation, we are one of the only stakeholders other than DHS who actively participate in all aspects of child welfare cases.

We believe that the current form of this bill is the right compromise that will meet the needs of involving relatives in the child welfare process and also keep in mind the most important part of a child welfare case – the child.

In its current form SB2730 SD2 HD1 will confer a preference to family members in the placement of children during the initial removal of a child from his or her parent, at the same time it will preserve the ability for the court in its discretion to continue custody of a child in a non-relative placement upon termination of parental rights.

In addition, the bill will require the Department of Human Services to make reasonable efforts to identify relatives within six months of a child entering foster custody, and report to the court in DHS' safe family home reports on their efforts to identify relatives. It would also require DHS to send an application to any relatives inquiring about becoming a foster parent within fifteen days and provide written notice if the relative is denied stating the reason for denial as well as information regarding the administrative process.

I am a Licensed Social Worker in Hawaii, and have worked both for the Department of Human Services, Child Welfare Services, and for private agencies. Over the past 10 years I have worked with foster children, foster families, and biological families in a variety of different settings. In my work with children displaced from their family home, I have seen how critical it is for these children to maintain family ties. When children are connected to their family and culture, they tend to develop a stronger sense of identity and self-worth. Children who were placed with relatives, including grandparents, may experience more stability, tend to do better in school, and experience greater success as adults. Children who enter foster care have experienced trauma, aubuse, and neglect. If the system of care can minimize other changes and sources distress, children will be better able to concentrate on being a child – developing a secure sense of self and establishing their place in the world. Research shows that kinship placement provides more continuity in family relationships and community ties and is less traumatic and disruptive than non-kin foster care.

By establishing a relative preference, we are moving forward in our drive to truly protect children and decrease the trauma they experience. The passage of this bill would only serve to give foster children an opportunity to experience increased stability and to develop a better sense of self and their place in this world. Support of SB 2730 H.D. 1, Relating to Child Protection

Aloha. My name is Nina Sacks and I am currently pursuing my Masters Degree in Social Work at the University of Hawaii at Manoa. A member of the Hawaii Child Welfare Education Collaboration, funded under Title IVE of the Legislature, I conduct my internship within an agency that assesses, trains, and licenses relative and kin foster parents. Upon obtaining my degree I am contracted to be employed for a minimum of 2 years within Child Welfare Services, the Department of Human Services.

When children are removed from an abusive or unsupervised home, it is our hope that they find a safe, nurturing, and loving family within which they can heal and thrive. Regardless of the circumstances, removing children from their parents is painful and traumatic. In addition to leaving their loved ones, they often must change schools, friends, counselors, etc., and may lose contact with everything that has been their foundation thus far.

By making every effort possible to place children within the homes of appropriate blood relatives or non-related kin, we are striving to provide a sense of continuity and stability. We send a message that we respect and value where children come from and who they are. Prioritizing kinship placements gives children a greater chance of remaining within their communities and living with others who share their cultural heritage. It may reduce the potential trauma of separation by ensuring that the ties and familiarity that are crucial to the well-being of children are maintained.

I believe it to be extremely important that the policies we have in place clarify the necessity for the department to make a preference in seeking appropriate kinship placements for foster youth prior to placing children in general licensed homes. I urge the committee to pass SB 2730 H.D. 1. Thank you for this opportunity to testify.

I never testified before, but I am now because I'm a foster care youth and I feel so strongly about this bill. I think all grandparents should know what is happening with their grandchildren. They should get custody, so that we foster kids don't have to live with people we don't know.

For ten or eleven years I didn't see my grandparents. When I finally did get to see them, they were happy. They had been wondering what had happened to me! I was happy to see them too. For ten years I had thought one of my grandmas was dead. I was shocked and very happy to find out she was alive! We both cried when we finally got to hug each other.

Grandparents should have equal rights to foster parents. All grandparents should be notified and get custody when their grandchildren are taken into custody by CPS. I would have loved to have lived with my grandmother. Then I would have known my family all these years.

#### SB 2730 RELATING TO CHILD PROTECTION.

Establishes a grandparent preference for placement of children needing child protective services.

### Regarding What Should Happen When Children Taken into DHS-CPS Custody.

When Child Protective Services Investigations show child (ren) at risk of harm to the degree that the child must be removed, we depend on the Department of Human Services to early on take steps to find the grandparents and relatives for assessment of their capacity to keep the child safe and nurtured. It makes sense to give preference to the capable grandparent or relative (including hanai with whom a child is strongly bonded). There is a natural connection. Time is of essence for DHS to find child's relatives.

## Regarding How

- Heavy responsibility lies with DHS Worker/Supervisor to find grandparents/relative, assess, give them preference to be needed Foster Family for a child in DHS Custody.
- The DSH-CPS assessment should be extended whenever the child (ren) had been left (by parents) with a hanai caregiver for a period of time that resulted in the child (ren) feeling a strong bond to that caregiver.
- 'Ohana Conferencing should include both biological and hanai grandparents for discussion about *Best Interest of Child (ren)*.

For more that sixteen years, advocates have encouraged DHS to find grandparents, relatives, hanai caregivers, assess, and put the children there to grow up where the child feels bonded. Within the last year, DHS has a contract for assistance to DHS Social Workers for finding relatives as soon as possible.

SB 2730 has assurances that there are short timelines for DHS to actually make it happen: grandparents and relatives contacted, assessed, and given preference for Foster Care and if a plan is needed, Adoption.

### Please support this bill.

### Your support would end nightmarish tragedies as often happened and left a grieving community:

- CPS-DHS removed child [from angry parents who won't identify grandparents or relatives because parents hide illegal activities from family.]. DHS placed child in the first available foster home, then didn't actively pursue to find grandparents or relatives. Months passed, *DHS Adoption Plan* moved to be heard in Family Court. Non-relative foster parents fell in love with the child (who was doing fine with them). The foster parent wanted to adopt the child. The worker supported that plan.
- Meanwhile, grandparents and relatives (1) didn't know that CPS picked up the baby or child; (2) are wondering "Where are the kids, where is my grandchild?" (3) Searched for the child and learned the grandchild was in a DHS Foster Home.
- The grandparent or relatives contacted DHS and learned that the *DHS Plan* was for the non-relative foster parents to adopt the child (their grandchild!). In court, the Judge consented to the DHS Plan.
