## SB 2735 RELATING TO MINORS.

Allows minors to consent to entering into emergency shelters or other homeless facilities when minors do not have a parent or guardian to consent on their behalf.

If minors could enter into emergency shelters or other homeless facilities when they do not have a parent or guardian to consent on their behalf, that gives those minors an option for safety, supports, and opportunity to learn about available options for them.

Without a safe refuge and supports, those minor have to find their way on the streets. Consequences impact the rest of their lives.

## Testimony on SB 2735 Relating to Minors

Hawaii Youth Services Network, a statewide coalition of more than 50 youth serving organizations, supports the intent of SB2246 Relating Minors.

Current Hawaii law requires parents or guardians to provide consent before a minor may be admitted to an emergency shelter. There are times when consent cannot be obtained because a parent/guardian cannot be reached or refuses consent. At that point, unless Child Welfare Services opens an abuse or neglect investigation, the shelter cannot admit the youth and he or she will remain on the street.

Runaway and homeless youth on the streets are at high risk for assault and sexual victimization, have no safe or appropriate place to sleep, and lack adequate nutrition.

Enabling youth to provide consent for shelter when parental/guardian consent cannot be obtained will increase the safety and well-being of these youth.

HYSN believes that further discussion is needed to address the following concerns:

- An emergency shelter provides only short-term shelter (usually 14 days or less). What services and resources will be available to these youth following the shelter stay?
- What is the role of Child Protective Services in such situations?
- How may we address the legal liability concerns of shelter providers\?
