SENATE BILL NO. 2915 RELATING TO TARO

Chairpersons Tokuda and Inouye and Members of the Committees:

Thank you for the opportunity to provide testimony on Senate Bill No. 2915 relating to taro. The purpose of this bill is to create the Taro Security and Purity Task Force and to appropriate funds for that purpose. The department offers comments.

During the 2007 legislative session, taro farmers and members of the Native Hawaiian community expressed growing concern over increasing threats to taro. Senate Concurrent Resolution 206 was adopted in April 2007, and requested the department to develop a taro security and purity research program that is designed to ensure that taro can be saved and protected from natural attack.

The program requires two parts: 1) regulatory elements that will be implemented in conjunction with the Congressional delegation, Legislature, and federal quarantine agencies through the implementation of the department's biosecurity program; and 2) non-regulatory elements through the establishment of a task force that would guide policy and prioritize research for the protection of taro in Hawaii.

The Hawaii Department of Agriculture's proper role in the program is to provide increased protection for taro through the implementation of the biosecurity program.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> S.B. 2915, which would establish the Taro Security and Purity Task Force within the state Department of Agriculture. The task force would be funded with \$650,000 from the state general fund for the 2008-2009 fiscal year. The task force would be responsible for continuing the dialogue on protecting taro among taro farmers, the Native Hawaiian community, scientists and various government agencies.

OHA commends the positive and productive dialogue on the protection of taro that occurred throughout 2007 as a result of Senate Concurrent Resolution 206, Session Laws of Hawaii 2007.

We believe that continued dialogue is needed to revive the taro industry and to ensure that the culturally significant practice of mahi'ai kalo (taro farming) continues to thrive.

OHA urges the Committee to PASS S.B. 2915. Thank you for the opportunity to testify.

Aloha,

My name is Jim Cain. My family and I farm taro in Waipi'o Valley on the Big Island. We also own and operate a family run poi shop where we process the taro from our 6 acre farm, as well as taro we obtain from other farmers, providing poi for our Big Island community. I fully support SB2915 that calls for the formation of a taro task force. SCR206 which came out of last year's session, authorized DOA to develop a taro security and purity program, opened up state-wide dialogue between taro farmers, DOA, Farm Bureau, and CTAHR. At the final stakeholder's meeting in Oct. 2007, it was agreed that dialogue should continue and that this should be in the form of a funded task force that would include representatives from all the above parties.(See DOA report in response to SCR206). At a meeting held last week at the Capitol, attended by reps from all the afore mentioned parties it was again unanimously agreed upon to proceed with the task force. I would like to suggest some changes to the initial bill.

Section 2. Instead of DOA, OHA should be the administrative agency. Both DOA and OHA have agreed to these changes. We are looking into matching funding to be contributed by OHA.

Section 8. Subsections 1, 2 and 5 should be combined and should read:

\$375,000 for the convening of the taro security and purity task force and the conducting of dialogues on all islands, developing and implementing programs that will support the work of taro growers, retaining a minimum of at least one person to facilitate, coordinate, communicate, and record the work of the task force, and prepare the final report to be submitted to the legislature.

The proposed changes would give the task force the much needed flexibility to actually perform concrete steps to help the taro farmers. Again, I would like to stress the agreement from all parties that this would be the most effective way to move forward to coordinate our efforts and help the taro farmers. Any time we can build support and cooperation from the ground (or should I say lo'i) up, we stand to have much more support and buyin from all. From the taro farmers of Waipi'o Valley, I thank you for you support.
