RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM

Chair Oshiro and Members of the Committee:

The Board of Trustees supports the original intent of this Administration bill which amends various provisions of Chapter 88, Hawaii Revised Statutes to clarify and conform existing statutes to current practice.

The Board of Trustees also recommends the following amendments to help members in the upcoming Hybrid Plan conversion and comply with federal tax law changes affecting the Hybrid Plan:

- Allow members to rollover and transfer funds to ERS from their deferred compensation plans, tax sheltered annuities, IRAs, and private pension plans to purchase membership service credits or to upgrade their Noncontributory Plan service to Hybrid Plan service.
- Allow payments for the Hybrid Plan conversion with "after-tax" employee payroll deductions. The Internal Revenue Service will no longer allow members to defer federal income taxes on their payroll deductions to upgrade membership service credits.
- Prohibit returning vested Contributory Plan members the option to switch to the Hybrid Plan after June 30, 2008. An election to switch retirement plans is now prohibited by the Internal Revenue Service.

Since this Bill requires other substantial technical changes, we recommend that this Bill be revised back to the provisions in S.B. 3004, S.D. 2 to carry out the above recommendations.

## RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM

Senate Bill No. 3004 makes various amendments to Chapter 88, Hawaii Revised Statutes, which govern the Employees' Retirement System (ERS). These changes clarify existing language and conform current statutes with ERS' operating practices, address federal requirements, and make various streamlining and housekeeping amendments. House Draft (HD) 1 deletes various changes recommended by the ERS to ensure that the Hybrid Plan is in compliance with federal tax and law changes.

The Department of Budget and Finance supports Senate Draft 2 of this bill as it will result in improved ERS performance, streamline day-to-day operations, and meet ERS' federal tax qualification requirements.
