State Ethics Commission advice relating to HCDA Members

We have reviewed the advice issued by the State Ethics Commission's Executive Director (Commission) to Paul Kimura, a member of the Hawaii Community Development Authority (HCDA), and confirm our disagreement with the Commission's conclusion that Mr. Kimura is a mandated member of HCDA board.

We understand that the Commission originally advised Mr. Kimura that as owner and president of City Fender & Body Service, Ltd. (City Fender), a small business located in the Kakaako Community Development District (Kakaako District), he was precluded from "...participating in policy-making, planning or rule-making or taking other official action directly affecting small business owners in the Kakaako District as a whole, because it appeared that such official action would directly affect City Fender." The Commission staff based its advice on Section 84-14(a), Hawaii Revised Statutes (HRS), which prohibits a state employee from taking official action directly affecting a business or undertaking which he has a substantial financial interest.

After receiving a letter dated July 16, 2007, from Senate President Colleen Hanabusa and House Speaker Calvin Say of the Hawaii State Legislature (Legislative Letter), the Commission staff issued a written opinion reversing its original verbal advice. The Commission staff relied on the statement in the Legislative Letter indicating that the Legislature had intended for small business to be represented on the HCDA board and that Mr. Kimura was appointed to the board for that very reason. Furthermore, the Commission's opinion letter set forth that said legislators will be

supporting the amendment of Section 206E-3, HRS, in the 2008 Legislative Session to require small business representation on the HCDA board.

It is our opinion that the Commission staff erred in relying on the Legislative Letter to explain legislative intent of Section 206E-3, HRS. It is our opinion that Mr. Kimura has a definite conflict of interest in matters directly affecting his business interests. We, therefore, advise that Mr. Kimura refrain from taking action on HCDA matters directly affecting his business or undertakings in which he has a substantial financial interest until and unless Section 206E-3, HRS, is amended or another law is passed allowing action to be taken by members having an interest in the matter in question.

This recommendation would also apply to any other Kakaako small business owner presently appointed to the HCDA board.
