**Purpose of Resolution:** 

Urging the department of education to include shaded play areas in plans for all new elementary schools and to establish and phase in a plan to provide shaded play areas on the grounds of all existing elementary schools by 2011.

Department's Position:

The Department of Education does not support this resolution. While we agree with the need to protect against sun exposure, we feel there are more appropriate means for doing so than via shaded play areas in schools, including educational campaigns encouraging the use of sunscreen for students and the community at-large.

Shaded areas are currently given consideration during the design phase in the form of covered playcourts and landscaping. However, cost is an issue on some projects, and we feel that the participants in the design phase should retain the flexibility to consider cost reduction alternatives that include the deletion of a shade structure if other design components have a higher utility.

For existing schools, funding for classrooms and compliance projects is always short of what is needed. We feel it would be more appropriate to direct our limited funds toward those types of projects.
