"A BILL FOR AN ACT RELATING TO HISTORIC PRESERVATION,"

begs leave to report as follows:

The purpose of this bill is to preserve and protect the Kohala Historic Sites State Monument (Monument) by requiring:

- (1) The Department of Land and Natural Resources to consult with the kahana nui of the Mo'okini Heiau prior to making alterations or improvements to the Monument, except for routine maintenance; and
- (2) Any entity to consult with the kahana nui of the Moʻokini Heiau prior to any additional organized profit-making ventures involving the Monument, including the Moʻokini Heiau.

The Department of Land and Natural Resources and Moʻokini Luakini, Inc., testified in support of this bill. The Office of Hawaiian Affairs supported this measure with amendments.
