Your Committee on Education, to which was referred S.B. No. 2035 entitled:

"A BILL FOR AN ACT RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS FOR MAUI PREPARATORY ACADEMY,"

begs leave to report as follows:

The purpose of this measure is to assist nonprofit private schools that serve the general public through the authorization of the issuance of special purpose revenue bonds to assist Maui Preparatory Academy in the planning and construction of its educational facilities.

Testimony in support of this measure was submitted by the Hawaii Association of Independent Schools and Maui Preparatory Academy.

Your Committee finds that pursuant to part VIII, chapter 39A, Hawaii Revised Statutes, special purpose revenue bonds may be issued to assist not-for-profit private nonsectarian and sectarian elementary schools, secondary schools, colleges, and universities that serve the general public. This measure will support the educational needs of the State's children by allowing Maui Preparatory Academy to improve the lower, middle, and upper school facilities to allow for expansion to a full pre-kindergarten to twelfth grade school without relying entirely on the monetary contributions of the school's alumni, friends, and other supporters. Your Committee believes that the issuance of special

purpose revenue bonds under this measure is in the public interest and for the public's general welfare.

Your Committee has amended this measure by making technical, nonsubstantive changes for purposes of clarity and style.

As affirmed by the record of votes of the members of your Committee on Education that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 2035, as amended herein, and recommends that it pass Second Reading in the form attached hereto as S.B. No. 2035, S.D. 1, and be referred to the Committee on Ways and Means.
