STATEMENT OF OBJECTIONS TO SENATE BILL NO. 777

Honorable Members Twenty-Fifth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 777, entitled "A Bill for an Act Relating to Comprehensive Sexuality Health Education."

This bill requires sexual health education programs that receive State funding to provide medically accurate and factual information that is age appropriate that includes education on abstinence, contraception, and prevention of unintended pregnancies and sexually transmitted diseases when engaging in intercourse.

This bill is objectionable because it will prohibit the use of State funds for a legitimate, proven form of sex education that encourages children to abstain from sexual intercourse.

Programs such as "Try Wait," offered by Catholic Charities, help teenagers to understand the implications of sexual activity and the options of refraining from such activity. According to data collected by the U. S. Department of Health and Human Services, Hawaii ranks 12th in the nation in teen pregnancies and 10th in the nation in sexually transmitted diseases. Students and their parents deserve to have options that provide instruction in and encourage abstinence.

The State Department of Health and the State Department of Education already provide medically accurate and factual content in the sexual health education programs they offer. The Board of Education's Policy No. 2110 requires schools'

abstinence-based education programs to include information on protective devices and methods for preventing pregnancy and sexually transmitted diseases. Should the Department of Education elect to teach courses that focus on abstinence only that do not include instruction on preventing pregnancies and sexually transmitted disease, this bill would prohibit these education programs from receiving State funds.

For the foregoing reasons, I am returning Senate Bill No. 777 without my approval.

A BILL FOR AN ACT

RELATING TO COMPREHENSIVE SEXUALITY HEALTH EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The federal government spends over \$170,000,000
2	per year to subsidize states and community organizations that
3	provide abstinence-only-until-marriage sex education to youth in
4	the United States. Abstinence-only-until-marriage sex education
5	teaches that the expected standard of human sexual activity is a
6	monogamous, marital, heterosexual relationship and that sex
7	outside such a relationship is physically and psychologically
8	harmful. Abstinence-only education advocates that abstinence is
9	the only method that can effectively prevent disease and
10	pregnancy and provides no additional information about
11	contraception or alternative methods of disease prevention.
12	In April 2007, a federally funded report found abstinence-
13	only education to be ineffective. The study found that youth
14	receiving abstinence-only education had the same abstinence
15	rate, average age at first intercourse, and average number of
16	sexual partners as youth who did not participate in abstinence-
17	only programs. Report researchers concluded that the recent

- 2 most likely the result of improved use of contraception rather
- 3 than a decrease in sexual activity.
- 4 As of September 2008, twenty-five states have refused to
- 5 participate in abstinence-only programs. These states instead
- 6 support a comprehensive sexuality education that provides
- 7 responsible, age-appropriate instruction on the benefits of
- 8 abstinence as well as a variety of issues related to sexuality,
- 9 contraception, and disease prevention.
- 10 The purpose of this Act is to require any recipient of
- 11 state funding specifically for sexuality health education
- 12 programs to provide medically accurate, factual, and
- 13 comprehensive information that is age appropriate and includes
- 14 education on abstinence and contraception.
- 15 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 16 amended by adding a new section to be appropriately designated
- 17 and to read as follows:
- 18 "§321- Medically accurate sexuality health education.
- 19 (a) Sexuality health education programs funded by the State
- 20 shall provide medically accurate and factual information that is
- 21 age appropriate and includes education on abstinence,
- 22 contraception, and methods of disease prevention to prevent

- unintended pregnancy and sexually transmitted disease, including
 human immunodeficiency virus.
- 3 (b) For the purposes of this section:
- 4 "Age appropriate" means suitable to a particular age or age
- 5 group based on developing cognitive, emotional, and behavioral
- 6 capacity typical for that age or age group.
- 7 "Factual information" means medical, psychiatric,
- 8 psychological, empirical, or statistical information that is
- 9 verified or supported by research conducted by recognized
- 10 medical, psychiatric, psychological, and public health
- 11 professionals or organizations.
- "Medically accurate" means verified or supported by
- 13 research conducted in compliance with accepted scientific
- 14 methods and recognized as accurate and objective by professional
- 15 organizations and agencies with expertise in the relevant field,
- 16 such as the federal Centers for Disease Control and Prevention,
- 17 the American Public Health Association, the American Academy of
- 18 Pediatrics, and the American College of Obstetricians and
- 19 Gynecologists.
- "Sexuality health education" means education in any medium
- 21 regarding human development and sexuality, including education

- 1 on pregnancy, family planning, and sexually transmitted
- 2 diseases."
- 3 SECTION 3. New statutory material is underscored.
- 4 SECTION 4. This Act shall take effect upon its approval.
