A BILL FOR AN ACT

RELATING TO PRIVATE AGRICULTURAL PARKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that many times necessary		
2	cooperation between and among adjoining and neighboring		
3	agriculturalists is stifled by governmental regulation and		
4	oversight.		
5	The purpose of this Act is to encourage owners of		
6	neighboring agricultural lands to enter into private agreements		
7	to reduce the shared costs of generating and transmitting		
8	electrical energy, cold water for refrigeration and cooling, and		
9	nonpotable water for irrigation.		
10	SECTION 2. The Hawaii Revised Statutes is amended by		
11	adding a new chapter to be appropriately designated and to read		
12	as follows:

14	PRIVATE AGRICULTURAL PARKS		
15	§ -1 Private agricultural parks. (a) The owners of		
16	one or more contiguous parcels, including public lands, within		
17	the agricultural district may establish a private agricultural

- 1 agreement with the department of agriculture, on forms 2 prescribed and prepared by the department, which shall include 3 the following information for each private agricultural park: 4 (1)The names and addresses of all the parties; 5 The tax map parcel numbers and number of acres in each (2) 6 parcel to be included in the private agricultural 7 park; 8 (3) The types of agricultural activities and products 9 being produced or to be produced by each party, **10** including non-agricultural by-products that may 11 include renewable sources of energy for the production 12 of electrical energy or liquid fuel and cold water for 13 cooling, processing, and air conditioning purposes; 14 and 15 Other information that the department of agriculture (4) 16 determines may be of assistance in promoting the 17 private agricultural park; 18 provided that, by subsequent filings, a private agricultural 19 park may add or delete parties and parcels from its original **20** filing.

4 Engage in the generation of electrical energy from (1)5 fossil fuel or renewable energy sources, including the 6 use of falling water, biomass, wind, and solar energy. 7 Any electrical energy generated within the boundaries 8 of the private agricultural park, whether by a party 9 or parties to the agreement or through an agreement **10** between a party or parties and a nonparty independent 11 energy producer, may be produced, sold, transmitted, 12 and consumed by any other party of the private 13 agricultural park agreement; provided that the 14 electrical energy generated is used for agricultural 15 purposes including but not limited to the pumping of 16 agricultural water, cooling, air conditioning, or 17 agricultural processing; provided further that the 18 electrical energy generated is used within the 19 established boundaries of the private agricultural **20** park; and provided further that the transmission and 21 distribution system is solely owned by a party of the 22 private agricultural park agreement;
