A BILL FOR AN ACT

RELATING TO FARMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. (a) There is established in the department of
2	agriculture a food certification pilot program to benefit	
3	farmers throughout the state.	
4	(b)	The pilot program shall be managed by the department
5	of agriculture; provided that the department of health shall	
6	provide t	ne department of agriculture with assistance as
7	necessary	in implementing the pilot program. The pilot program
8	shall:	
9	(1)	Encourage farmers to form agricultural cooperatives;
10	(2)	Coordinate purchasing agreements between the
11		agricultural cooperatives and hotels, restaurants, and
12		other buyers in the visitor and hospitality
13		industries; and
14	(3)	Develop and implement "safe" food certification for
15		products under the pilot program to promote fresh,
16		high-quality, locally-grown produce grown by Hawaii
17		farmers.

- 1 All farmers operating in the state shall be eligible to apply
- 2 for the pilot program.
- 3 (c) There is established in the state treasury the food
- 4 certification pilot program special fund, into which shall be
- 5 deposited:
- **6** (1) Appropriations made by the legislature;
- 7 (2) Gifts and grants; and
- **8** (3) Any other moneys available to the food certification
- 9 pilot program special fund from other sources.
- 10 (d) The moneys in the food certification pilot program
- 11 special fund shall be used by the department of agriculture for
- 12 the purposes of this Act.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$160,000 or so much
- 15 thereof as may be necessary for fiscal year 2009-2010 and the
- 16 same sum or so much thereof as may be necessary for fiscal year
- 17 2010-2011 to be deposited into the food certification pilot
- 18 program special fund established in section 1 of this Act.
- 19 SECTION 3. There is appropriated out of the food
- 20 certification pilot program special fund the sum of \$160,000 or
- 21 so much thereof as may be necessary for fiscal year 2009-2010
- 22 and the same sum or so much thereof as may be necessary for



- 1 fiscal year 2010-2011 for the operations of the food
- 2 certification pilot program established in section 1 of this
- 3 Act.
- 4 The sums appropriated shall be expended by the department
- 5 of agriculture for the purposes of this Act.
- 6 SECTION 4. This Act shall take effect on July 1, 2110, and
- 7 shall be repealed on June 30, 2011; provided that all unexpended
- 8 and unencumbered moneys remaining in the food certification
- 9 pilot program special fund on June 30, 2011, shall lapse to the
- 10 credit of the general fund.
