A BILL FOR AN ACT

RELATING TO CHILDREN'S HEALTH CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 236, Session Laws of Hawaii 2007, is amended by amending section 3 to read as follows: 2 "SECTION 3. (a) There is established the Hawaii 3 4 children's health care program as a temporary [three-year] pilot 5 program to provide health care coverage to uninsured children 6 who live in Hawaii. The department of human services shall 7 provide health care coverage through a public-private 8 partnership, established as a contract to provide health and 9 human services pursuant to chapter 103F, Hawaii Revised 10 Statutes, between the department and one or more managed care 11 plans operating in the state under chapter 432, Hawaii Revised Statutes, that offers accident and health or sickness insurance 12 13 plans.

14 (b) It is not the intent of the legislature to discourage 15 employers from offering to pay, or from paying for, dependent 16 coverage for their employees, nor that this Act supplant 17 employer-sponsored dependent coverage plans.

18 (c) To qualify, a child shall:
