

A BILL FOR AN ACT

RELATING TO CORRECTIONAL FACILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 328J-7, Hawaii Revised Statutes, is
 amended to read as follows:

3 "[+]\$328J-7[+] Exceptions. Notwithstanding any other
4 provision of this chapter to the contrary, the following areas
5 shall be exempt from the provisions of sections 328J-3, 328J-4,
6 and 328J-5:

7 (1) Private residences, except when used as a licensed 8 child care, adult day care, or health care facility; 9 Hotel and motel rooms that are rented to quests and (2)are designated as smoking rooms; provided that not 10 more than twenty per cent of rooms rented to guests in 11 12 a hotel or motel may be so designated. All smoking rooms on the same floor shall be contiguous and smoke 13 from these rooms shall not infiltrate into areas where 14 smoking is prohibited under this chapter. The status 15 16 of rooms as smoking or nonsmoking may not be changed, except to add additional nonsmoking rooms; 17

14	(6)	All areas covered by this chapter when smoking is part
15		of a production being filmed; and
16	(7)	State correctional facilities[-]; provided that
17		smoking shall only be authorized for employees and
18		volunteers of a correctional facility in an area
19		outside the secure confines of a correctional facility
20		restricted from access by inmates or detainees that
21		has been designated by the warden of a correctional
22		facility."
