A BILL FOR AN ACT

RELATING TO THE ECONOMY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 201-19, Hawaii Revised Statutes, is
2	amended by amending subsection (b) to read as follows:
3	"(b) The department shall submit to the legislature no
4	later than twenty days prior to the convening of each regular
5	legislative session, a [written performance report on the impact
6	of activities of the department and attached agencies that
7	demonstrate their efforts to support, promote, and facilitate
8	the expansion and long-term viability of emerging growth
9	industries including those identified in subsection (a) (1).
10	report that provides an update on the criteria used to measure
11	growth of these emerging growth industries. In updating its
12	reports on the growth of emerging growth industries each year,
13	the department shall develop updated measurements and analyses
14	in collaboration with the University of Hawaii, county economic
15	development boards, and private, non-profit economic research
16	groups."

Science and Technology; Hawaii State Plan; Economy Growth

Description:

Amends the Hawaii State Planning Act to include references to science, technology, and related growth industries in Hawaii. Amends the Department of Business, Economic Development, and Tourism's reporting requirement to the Legislature on the growth industries of Hawaii. (SB1195 HD2)
