A BILL FOR AN ACT

RELATING TO NON-GENERAL FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Many unprecedented events have converged to
3	create an economic, financial, and fiscal environment that
4	threatens the very foundation of our national economy. Problems
5	that arose in the national housing sector and sub-prime mortgage
6	market last year have radiated from Wall Street to Main Street.
7	Across the United States, the result has been increasing
8	business bankruptcies and closures, lower consumer confidence
9	and spending, and job losses and rising unemployment.
10	For state governments, the financial crisis and economic
11	downturn have adversely impacted tax revenues and budgets. Most
12	states, like Hawaii, rely on income and sales taxes as their
13	main sources of revenues. The slowdown in employment and
14	consumer spending has reduced state revenues nationwide at a
15	time when operating costs continue to rise.
16	Hawaii is experiencing a severe contraction in its visitor,
17	retail, and construction industries. As a consequence, the

- 1 council on revenues has lowered its revenue projections five
- 2 times during 2008 and, once again, at the beginning of January
- 3 2009. The cumulative effect of these successive reductions in
- 4 revenue estimates for fiscal years 2008-2009, 2009-2010, and
- 5 2010-2011 is a substantial decrease in the amount of general
- 6 funds that the State can expect in the immediate and near
- 7 future. Given the level of spending and the anticipated rising
- 8 cost of state operations, a \$1,760,000,000 general fund budget
- 9 shortfall is projected by the end of fiscal year 2010-2011 if
- 10 corrective action is not taken.
- 11 The legislature finds that due to the extraordinary fiscal
- 12 crisis the State faces, non-general funds must be reviewed and
- 13 scrutinized to determine if excess balances are available. The
- 14 legislature further finds that transfers of excess balances are
- 15 needed to help address the critical budget shortfall in fiscal
- 16 biennium 2009-2011.
- 17 SECTION 2. Section 138-3, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "[+] §138-3[+] Wireless enhanced 911 fund. There is
- 20 established outside the state treasury a special fund, to be
- 21 known as the wireless enhanced 911 fund, to be administered by
- 22 the board. The fund shall consist of amounts collected under



- 1 section 138-4. [Moneys paid into the fund are not general fund
- 2 revenues of the State.] The board shall place the funds in an
- 3 interest-bearing account at any federally insured financial
- 4 institution, separate and apart from the general fund of the
- 5 State. Moneys in the fund shall be expended exclusively by the
- 6 board for the purposes of ensuring adequate cost recovery for
- 7 the deployment of phase I and phase II wireless enhanced 911
- 8 service and for expenses of administering the fund. Any funds
- 9 that accumulate in the wireless enhanced 911 fund shall be
- 10 retained in the fund unless determined by the legislature to be
- 11 in excess."
- 12 SECTION 3. Section 342G-104, Hawaii Revised Statutes, is
- 13 amended by amending subsection (c) to read as follows:
- "(c) Any funds that accumulate in the deposit beverage
- 15 container deposit special fund shall be retained in the fund
- 16 unless determined by the [auditor] legislature to be in excess[7]
- 17 after adjustments to the deposit beverage fee, pursuant to the
- 18 management and financial audits conducted in accordance with
- 19 section 342G 107]."
- 20 SECTION 4. The legislature determines that there is in the
- 21 wireless enhanced 911 fund at least \$9,000,000 in excess of the
- 22 requirements of the fund. On June 29, 2009, the director of



- 1 finance is authorized to transfer from the wireless enhanced 911
- 2 fund to the general fund the sum of \$9,000,000 or so much
- 3 thereof as may be necessary for fiscal year 2008-2009.
- 4 SECTION 5. The legislature determines that there is in the
- 5 deposit beverage container deposit special fund at least
- 6 \$20,000,000 in excess of the requirements of the fund. On June
- 7 29, 2009, the director of finance is authorized to transfer from
- 8 the deposit beverage container deposit special fund to the
- 9 general fund the sum of \$20,000,000 or so much thereof as may be
- 10 necessary for fiscal year 2008-2009.
- 11 PART II
- 12 SECTION 6. The legislature finds that section 37-53,
- 13 Hawaii Revised Statutes, provides the governor nearly unlimited
- 14 authority to transfer non-general funds to the general fund.
- 15 Section 37-53 provides that:
- 16 At any time during a fiscal year, notwithstanding any
- other law to the contrary, any department may, with
- 18 the approval of the governor or the director of
- 19 finance if so delegated by the governor, transfer from
- any special fund relating to such department to the
- 21 general revenues of the State all or any portion of
- 22 moneys determined to be in excess of fiscal year

1	requirements for such special fund, except for special
2	funds under the control of the department of
3	transportation relating to highways, airports,
4	transportation use, and harbors activities, special
5	funds under the control of the Hawaii health systems
6	corporation or subaccounts under the control of its
7	regional system boards, and special funds of the
8	University of Hawaii. At any time the department of
9	transportation, with the approval of the governor or
10	the director of finance if so delegated by the
11	governor, may transfer from any special fund under the
12	control of the department of transportation, or from
13	any account within any such special fund, to the
14	general revenues of the State or to any other special
15	fund under the control of the department of
16	transportation all or any portion of moneys determined
17	to be in excess of requirements for the ensuing twelve
18	months determined as prescribed by rules adopted
19	pursuant to chapter 91; provided that no such transfer
20	shall be made which would cause a violation of federal
21	law or federal grant agreements.

- 1 This part mandates the transfer of non-general funds to the
- 2 general fund.
- 3 SECTION 7. The legislature determines that there is in the
- 4 agricultural loan reserve fund at least \$500,000 in excess of
- 5 the requirements of the fund. On June 1, 2009, the director of
- 6 finance is authorized to transfer from the agricultural loan
- 7 reserve fund to the general fund the sum of \$500,000 or so much
- 8 thereof as may be necessary for fiscal year 2008-2009.
- 9 SECTION 8. The legislature determines that there is in the
- 10 agricultural loan revolving fund at least \$1,000,000 in excess
- 11 of the requirements of the fund. On June 1, 2009, the director
- 12 of finance is authorized to transfer from the agricultural loan
- 13 revolving fund to the general fund the sum of \$1,000,000 or so
- 14 much thereof as may be necessary for fiscal year 2008-2009.
- 15 SECTION 9. The legislature determines that there is in the
- 16 state risk management revolving fund at least \$5,000,000 in
- 17 excess of the requirements of the fund. On June 1, 2009, the
- 18 director of finance is authorized to transfer from the state
- 19 risk management revolving fund to the general fund the sum of
- 20 \$5,000,000 or so much thereof as may be necessary for fiscal
- 21 year 2008-2009.

- 1 SECTION 10. The legislature determines that there is in
- 2 the stadium special fund at least \$1,500,000 in excess of the
- 3 requirements of the fund. On June 1, 2009, the director of
- 4 finance is authorized to transfer from the stadium special fund
- 5 to the general fund the sum of \$1,500,000 or so much thereof as
- 6 may be necessary for fiscal year 2008-2009.
- 7 SECTION 11. The legislature determines that there is in
- 8 the medicaid investigations recovery fund at least \$1,500,000 in
- 9 excess of the requirements of the fund. On June 1, 2009, the
- 10 director of finance is authorized to transfer from the medicaid
- 11 investigations recovery fund to the general fund the sum of
- 12 \$1,500,000 or so much thereof as may be necessary for fiscal
- 13 year 2008-2009.
- 14 SECTION 12. The legislature determines that there is in
- 15 the state identification revolving fund at least \$600,000 in
- 16 excess of the requirements of the fund. On June 1, 2009, the
- 17 director of finance is authorized to transfer from the state
- 18 identification revolving fund to the general fund the sum of
- 19 \$600,000 or so much thereof as may be necessary for fiscal year
- 20 2008-2009.
- 21 SECTION 13. The legislature determines that there is in
- 22 the hydrogen investment capital special fund at least \$2,000,000

- 1 in excess of the requirements of the fund. On June 1, 2009, the
- 2 director of finance is authorized to transfer from the hydrogen
- 3 investment capital special fund to the general fund the sum of
- 4 \$2,000,000 or so much thereof as may be necessary for fiscal
- 5 year 2008-2009.
- 6 SECTION 14. The legislature determines that there is in
- 7 the housing finance revolving fund at least \$2,000,000 in excess
- 8 of the requirements of the fund. On June 1, 2009, the director
- 9 of finance is authorized to transfer from the housing finance
- 10 revolving fund to the general fund the sum of \$2,000,000 or so
- 11 much thereof as may be necessary for fiscal year 2008-2009.
- 12 SECTION 15. The legislature determines that there is in
- 13 the rental assistance revolving fund at least \$10,000,000 in
- 14 excess of the requirements of the fund. On June 1, 2009, the
- 15 director of finance is authorized to transfer from the rental
- 16 assistance revolving fund to the general fund the sum of
- 17 \$10,000,000 or so much thereof as may be necessary for fiscal
- 18 year 2008-2009.
- 19 SECTION 16. The legislature determines that there is in
- 20 the compliance resolution fund at least \$3,300,000 in excess of
- 21 the requirements of the fund. On June 1, 2009, the director of
- 22 finance is authorized to transfer from the compliance resolution

- 1 fund to the general fund the sum of \$3,300,000 or so much
- 2 thereof as may be necessary for fiscal year 2008-2009.
- 3 SECTION 17. The legislature determines that there is in
- 4 the drug demand reduction assessments special fund at least
- 5 \$1,000,000 in excess of the requirements of the fund. On June
- 6 1, 2009, the director of finance is authorized to transfer from
- 7 the drug demand reduction assessments special fund to the
- 8 general fund the sum of \$1,000,000 or so much thereof as may be
- 9 necessary for fiscal year 2008-2009.
- 10 SECTION 18. The legislature determines that there is in
- 11 the Hawaii tobacco settlement special fund at least \$33,000,000
- 12 in excess of the requirements of the fund. On June 1, 2009, the
- 13 director of finance is authorized to transfer from the Hawaii
- 14 tobacco settlement special fund to the general fund the sum of
- 15 \$33,000,000 or so much thereof as may be necessary for fiscal
- 16 year 2008-2009.
- 17 SECTION 19. The legislature determines that there is in
- 18 the neurotrauma special fund at least \$1,500,000 in excess of
- 19 the requirements of the fund. On June 1, 2009, the director of
- 20 finance is authorized to transfer from the neurotrauma special
- 21 fund to the general fund the sum of \$1,500,000 or so much
- 22 thereof as may be necessary for fiscal year 2008-2009.

- 1 SECTION 20. The legislature determines that there is in
- 2 the noise, radiation, and indoor air quality special fund at
- 3 least \$300,000 in excess of the requirements of the fund. On
- 4 June 1, 2009, the director of finance is authorized to transfer
- 5 from the noise, radiation, and indoor air quality special fund
- 6 to the general fund the sum of \$300,000 or so much thereof as
- 7 may be necessary for fiscal year 2008-2009.
- 8 SECTION 21. The legislature determines that there is in
- 9 the environmental health education fund at least \$400,000 in
- 10 excess of the requirements of the fund. On June 1, 2009, the
- 11 director of finance is authorized to transfer from the
- 12 environmental health education fund to the general fund the sum
- of \$400,000 or so much thereof as may be necessary for fiscal
- 14 year 2008-2009.
- 15 SECTION 22. The legislature determines that there is in
- 16 the emergency medical services special fund at least \$12,000,000
- 17 in excess of the requirements of the fund. On June 1, 2009, the
- 18 director of finance is authorized to transfer from the emergency
- 19 medical services special fund to the general fund the sum of
- 20 \$12,000,000 or so much thereof as may be necessary for fiscal
- 21 year 2008-2009.

1 SECTION 23. The legislature determines that there is in the vital statistics improvement special fund at least \$500,000 2 3 in excess of the requirements of the fund. On June 1, 2009, the 4 director of finance is authorized to transfer from the vital statistics improvement special fund to the general fund the sum 5 6 of \$500,000 or so much thereof as may be necessary for fiscal 7 year 2008-2009. 8 SECTION 24. The legislature determines that there is in 9 the clean air special fund at least \$8,000,000 in excess of the 10 requirements of the fund. On June 1, 2009, the director of 11 finance is authorized to transfer from the clean air special 12 fund to the general fund the sum of \$8,000,000 or so much thereof as may be necessary for fiscal year 2008-2009. 13 14 SECTION 25. The legislature determines that there is in 15 the environmental management special fund at least \$4,000,000 in excess of the requirements of the fund. On June 1, 2009, the 16 17 director of finance is authorized to transfer from the

- 15 excess of the requirements of the fund. On June 1, 2009, the
- 16 director of finance is authorized to transfer from the special
- 17 fund for disability benefits to the general fund the sum of
- 18 \$6,000,000 or so much thereof as may be necessary for fiscal
- 19 year 2008-2009.
- 20 SECTION 29. The legislature determines that there is in
- 21 the salvinia molesta removal special fund at least \$90,000 in
- 22 excess of the requirements of the fund. On June 1, 2009, the



- 1 director of finance is authorized to transfer from the salvinia
- 2 molesta removal special fund to the general fund the sum of
- 3 \$90,000 or so much thereof as may be necessary for fiscal year
- 4 2008-2009.
- 5 SECTION 30. The legislature determines that there is in
- 6 the special land and development fund at least \$2,000,000 in
- 7 excess of the requirements of the fund. On June 1, 2009, the
- 8 director of finance is authorized to transfer from the special
- 9 land and development fund to the general fund the sum of
- 10 \$2,000,000 or so much thereof as may be necessary for fiscal
- 11 year 2008-2009.
- 12 SECTION 31. The legislature determines that there is in
- 13 the Na Ala Hele program fund at least \$200,000 in excess of the
- 14 requirements of the fund. On June 1, 2009, the director of
- 15 finance is authorized to transfer from the Na Ala Hele program
- 16 fund to the general fund the sum of \$200,000 or so much thereof
- 17 as may be necessary for fiscal year 2008-2009.

- 19 SECTION 32. The purpose of this part is to repeal the
