# SENATE RESOLUTION

---

URGING THE UNIVERSITY OF HAWAII BOARD OF REGENTS TO CONSIDER A  
STRATEGIC DEVELOPMENT PLAN TO EXPLORE FUNDRAISING  
OPPORTUNITIES FOR THE UNIVERSITY OF HAWAII - WEST OAHU  
CAMPUS.

1 WHEREAS, in these difficult times when the economy is  
2 dwindling and the state budget is shrinking, state agencies need  
3 to look into a wide range of fundraising alternatives, even  
4 unconventional means; and

5  
6 WHEREAS, the new University of Hawaii - West Oahu campus in  
7 Kapolei is scheduled to open in 2011; and

8  
9 WHEREAS, the buildings and facilities of the University of  
10 Hawaii - West Oahu campus are not yet built; and

11  
12 WHEREAS, the University of Hawaii - West Oahu campus needs  
13 to attract stellar faculty; and

14  
15 WHEREAS, the University of Hawaii - West Oahu campus needs  
16 additional funds; now, therefore,

18 BE IT RESOLVED by the Senate of the Twenty-fifth  
19 Legislature of the State of Hawaii, Regular Session of 2009,  
20 that the University of Hawaii Board of Regents is urged to  
21 consider a strategic development plan to explore fundraising  
22 opportunities for the University of Hawaii - West Oahu campus;  
23 and

25 BE IT FURTHER RESOLVED that a strategic development plan  
26 include, at minimum:

27  
28 (1) Near- and long-term capital resources necessary for  
29 development and maintenance of planned West Oahu  
30 campus buildings and facilities;

32 (2) Identified sources of public and private funding, and  
33 the duration of the funding; and

1 (3) Alternative sources of funds, such as through the  
2 auction of naming rights for West Oahu campus  
3 buildings and facilities; the development of  
4 affordable workforce housing in concert with  
5 development of the West Oahu campus; and other  
6 fundraising options as deemed appropriate; and

8 BE IT FURTHER RESOLVED that the University of Hawaii Board  
9 of Regents is requested to submit a report of its findings and  
10 recommendations regarding a strategic development plan to  
11 explore fundraising opportunities for the University of Hawaii -  
12 West Oahu campus, to the Legislature no later than twenty days  
13 prior to the convening of the Regular Session of 2010; and

15 BE IT FURTHER RESOLVED that certified copies of this  
16 Resolution be transmitted to the Chair of the University of  
17 Hawaii Board of Regents, President of the  
18 University of Hawaii System, and Chancellor of the University of  
19 Hawaii - West Oahu campus.
