Your Committee finds that this nominee for reappointment to the Board of Professional Engineers, Architects, Surveyors, and Landscape Architects is one of two landscape architects on the Board and, as such, represents a valuable perspective on the Board. Your Committee finds that this nominee frequently attends national meetings of landscape architects and brings that information back to the Board. However, your Committee also notes that this nominee has a sporadic attendance record at Board meetings and, despite living on Oahu, did not attend either of the hearings that your Committee scheduled to hear this nomination.
