Madam:

Your Committee on Ways and Means, to which was referred H.B.  
No. 1057, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE STATE OF HAWAII COLLEGE  
SAVINGS PROGRAM,"

begs leave to report as follows:

The purpose of this measure is to allow third parties to  
contribute directly to a college savings account for a designated  
beneficiary.

Your Committee received one written comment on this measure.  
The written comment may be reviewed on the Legislature's website.

Your Committee finds that the TuitionEDGE program is a  
college savings program established by the State of Hawaii to  
assist students and parents in saving money for a college  
education. Your Committee finds that, currently, only the account  
owner is permitted to make contributions to TuitionEDGE accounts.  
Your Committee believes that, by allowing third parties, such as  
grandparents, friends, and other family members, to contribute  
directly to a college savings account, the TuitionEDGE program  
will grow and assist more families in reaching their educational  
goals.

Your Committee has amended this measure by changing the  
effective date to July 1, 2050, to facilitate further discussion.



As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 1057, H.D. 1, S.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as H.B. No. 1057, H.D. 1, S.D. 2.
