Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 371, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO TAXATION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this bill is to:

- (1)Increase the tax on naphtha sold for use in a powergenerating facility from 1 cent per gallon to 2 cents per gallon; and
- (2) Repeal the sunset date of the tax.

Your Committee on Conference has amended this measure by:

In lieu of making the tax permanent, extending it for an additional three years to December 31, 2012;

- (2) Changing its effective date to July 1, 2009; and
- (3) Making technical, nonsubstantive amendments for style, clarity, and consistency.
