Your Committee on Education, to which was referred H.B. No. 983 entitled:

"A BILL FOR AN ACT RELATING TO EDUCATION,"

begs leave to report as follows:

The purpose of this bill is to enhance traffic safety, especially around Hawaii's schools, by requiring the Director of Transportation to:

- Conduct a statewide pupil travel evaluation, through the Safe Routes to School Coordinator, to study how students get to school;
- (2) Use the information gained from the evaluation to provide funds to each school for school-based workshops and community-based planning to reduce vehicular traffic and congestion around schools, encourage walking and bicycling to school, and promote health and safety for students;
- (3) Develop a streamlined application process for federal Safe Routes to School grants; and
- (4) Submit to the Legislature a report of the results of the evaluation and the school-based workshops and communitybased planning projects funded by the Safe Routes to School Program.
