"HOUSE CONCURRENT RESOLUTION REQUESTING THE UNIVERSITY OF HAWAII'S PUBLIC POLICY CENTER TO MEET WITH, AND ADOPT THE RECOMMENDATIONS OF THE KANAKA MAOLI COMMITTEE WITH RESPECT TO THE CENTER'S REVIEW OF THE 2050 SUSTAINABILITY PLAN,"
