The purpose of this measure is to declare the month of April  
as "Child Abuse Prevention Month".

Your Committee finds that child abuse and neglect pose a  
serious threat to Hawaii's children. Your Committee supports the

abuse-prevention activities especially during the month of April.

Your Committee has amended this measure by making technical,  
nonsubstantive amendments for the purposes of clarity,  
consistency, and style.

Committee concurs with the intent and purpose of H.C.R. No. 44, as  
amended herein, and recommends its adoption in the form attached  
hereto as H.C.R. No. 44, S.D. 1.
