The Auditor is further requested to submit a report on its findings and recommendations to the Legislature at least twenty days prior to the convening of the Regular Session of 2010.

The American Cancer Society Hawaii Pacific, Inc. and the Hawaii Chapter-American Physical Therapy Association (HAPTA) submitted testimony in support of this resolution.


