Your Committee on Consumer Protection & Commerce, to which was referred S.B. No. 868, S.D. 2, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO ENERGY RESOURCES,"

begs leave to report as follows:

The purpose of this measure is to clarify and coordinate the responsibilities of various state agencies in the development of the State's energy resources in order to increase the use of indigenous renewable sources of energy and reduce the State's dependence on imported oil.

Your Committee received testimony in support of this measure from the Department of Business, Economic Development, and Tourism, Blue Planet Foundation, Hawaii Renewable Energy Alliance, and Honolulu Seawater Air Conditioning, LLC.

Your Committee finds that while various state agencies retain certain duties and responsibilities with regard to matters relating to energy resources, the Department of Business, Economic Development, and Tourism, through the energy resources coordinator, is responsible for developing and ensuring the achievement of the State's energy policies, programs, and plans. This measure clarifies the responsibility of the Director of the Department of Business, Economic Development, and Tourism who serves as the state energy resources coordinator, to develop and maintain a comprehensive and systematic quantitative and

qualitative capacity to analyze the status of energy resources, systems, and markets and to recommend and develop proposals to ensure the effectiveness of state policy and regulatory decisions.
