SB 1104 RELATING TO MOTOR VEHICLE INSURANCE. CPN

Testimony Requires all vehicles to display a decal affixed to the rear bumper as

proof of insurance.

Status

SB 1216 RELATING TO MOTOR VEHICLE INSURANCE. CPN

Testimony Prohibits the return of unearned premiums after cancellation of a motor vehicle insurance policy unless the insured provides proof of alternate

<u>Status</u> coverage or proof of transfer of title, theft of the vehicle, or

inoperability of the vehicle.

SB 53 RELATING TO INSURANCE. CPN

Testimony

Amends Act 177, Session Laws of Hawaii 2008 (Life Settlements Model Act) by repealing the requirement that the insurance

Status commissioner report annually to the legislature on the implementation

and effects of Act 177 and by making the Act permanent.

SB 1062 RELATING TO PROFESSIONAL EMPLOYER ORGANIZATIONS. CPN

Testimony Requires professional employer organizations to register with the

department of commerce and consumer affairs.

Status

SB 1129 RELATING TO ATHLETIC TRAINERS. CPN

Testimony Requires licensing of athletic trainers.

Status

SB 1223 RELATING TO HAWAII MADE PRODUCTS. CPN

Testimony Increases the percentage required for wholesale value added manufacture, assembly, fabrication, or production within the State

Status which is labeled "made in Hawaii."

Decision Making to follow, if time permits.
