<u>SB 384</u> <u>Testimony</u> <u>Status</u>	RELATING TO EDUCATION. Requires the department of education to ensure that all traffic safety measures are in place and operational prior to the opening of a newly constructed public or charter school. Requires the same of private schools.	EDH/TIA
<u>SB 735</u> <u>Testimony</u> <u>Status</u>	RELATING TO AFFORDABLE HOUSING. Requires the counties to identify and designate affordable housing receiving zones to facilitate the development of affordable housing.	EDH/TIA, WTL
<u>SB 737</u> <u>Testimony</u> <u>Status</u>	RELATING TO HOUSING. Authorizes mixed-use housing projects and infrastructure projects that are associated with a housing or mixed-use housing project to be eligible for the expedited review process currently offered to qualifying housing projects.	EDH/TIA, WTL
<u>SB 740</u> <u>Testimony</u> <u>Status</u>	RELATING TO HOUSING. Directs the department of land and natural resources and Hawaii housing finance and development corporation (HHFDC) to identify public lands within one-half mile of the city's transit corridor and within a one-mile radius of any designated transit station suitable for affordable housing. Requires governor to set aside the identified public lands for housing development. Requires the HHFDC to report to legislature.	TIA/EDH, WTL
