Creates the Facilities Alignment Commission to establish criteria for the selection of public schools to be constructed, expanded,

consolidated, or closed, and recommend a list of areas for new school construction, and of schools for expansion, consolidation, or closure.

recommendations if the legislature does not disapprove of them in their

entirety.
