SB 584 RELATING TO SOLID WASTE. ENE, JGO

Testimony Prohibits distribution of plastic shopping bags by retail stores and

supermarkets in the State.

Status

SB 245 RELATING TO RECYCLING. ENE, JGO/CPN

Testimony
Establishes a statewide at-store plastic carryout bag recycling program, requiring certain retailers to collect and recycle plastic bags in their stores. Creates a ban on plastic bags effective January 1, 2011.

SB 244 RELATING TO SOLID WASTE. ENE, CPN

Testimony Provides a refund or store credit to retail establishment customers who do not use plastic shopping bags offered by the retail establishment at

Status no additional charge.

SB 1671 RELATING TO FOSSIL FUELS. ENE, CPN

Testimony Prohibits the approval of any new electricity generating facilities using fossil fuel and the modification of existing electricity generating

<u>Status</u> facilities to allow the use of more fossil fuel.

SB 1260 RELATING TO AIR POLLUTION FEES. ENE, WAM

Testimony Removes the exemption from fees for air pollution emissions in excess

of 4,000 tons annually from covered sources.

Decision Making to follow, if time permits.
