SB 112 Testimony Status	RELATING TO THE CHILDREN'S JUSTICE PROGRAM. Establishes the confidentiality of children's justice program records, subject to exceptions for program and provider staff, mental and physical health professionals, and the courts.	HMS, JGO

SB 134 RELATING TO CHILDREN. HMS, JGO

Testimony

Extends the time the department of human services may assume temporary foster custody of a child without an order of the court from three to five working days to allow for more time to conduct an investigation. Possible the department to conduct an observation of the court from the conduct and investigation.

investigation. Requires the department to conduct an ohana conference prior to deciding what course of action to take.

SB 186 RELATING TO FOSTER CARE SERVICES. HMS, WAM

Testimony

Increases the monthly board rate distributed by the department of

human services for foster care services for children.

<u>Status</u>

SB 224 RELATING TO CHILD ABANDONMENT. HMS, JGO

<u>Testimony</u>

Makes it a misdemeanor to abandon a child by leaving the child with a person whose identity cannot be proven or who cannot be later located.

**Status** 

SB 227 RELATING TO PUBLIC SAFETY. HMS, JGO

Testimony Prohibits registered sex offenders from entering upon and loitering within restriction zones around schools and child care facilities.

<u>Status</u> Imposes penalties.

SB 252 RELATING TO SOCIAL SERVICES. HMS, WAM

Prohibits the use of an electronic benefits transfer card for the purchase of alcoholic beverages or tobacco, or as part of a transaction in which alcoholic beverages or tobacco are purchased by means other than an electronic benefits transfer card; requires the department of human services to establish a program to pay rental payments directly to the owner of the rental property for any person eligible for rental financial assistance by the department; requires the department to establish rules

for both programs.

SB 312 RELATING TO LANGUAGE ACCESS. HMS, JGO

Testimony

Designates the month of September as "language access month" to promote awareness of language access for government services and to emphasize the importance of and the need for language access in

Hawaii.

SB 338 RELATING TO TAXATION. HMS, WAM

Testimony

Amends Hawaii Revised Statutes section 235-1 to include the

definition of "totally disabled."
