RELATING TO SMALL BUSINESS. HB 1428, HD1 EBM, JUD, FIN (HSCR111) Makes various administrative and technical amendments to the Small Status Business Regulatory Flexibility Act. Codifies the Small Business Bill Of Rights. (HB1428 HD1) HB 1622, HD1 RELATING TO THE SMALL BUSINESS REGULATORY REVIEW EBM, JUD, FIN (HSCR86) BOARD. Status Requires the small business regulatory review board to identify rules that shall be amended or repealed to conform to the repeal of related statutes. Directs the board to work with state agencies to develop a procedure for expediting the amendment or repeal of rules when the changes are required only to comply with the repeal of statutes. (HB1622 HD1) RELATING TO LAW ENFORCEMENT. JUD, FIN HB 1293 Status Provides grants to the counties for victim witness assistance programs and career criminal prosecution units. HB 1163 RELATING TO HARBORS. TRN, JUD, FIN (HSCR245) Authorizes the Department of Transportation to impose upon private Status parties who use state commercial harbors the duty to defend, indemnify and hold harmless the State against claims that arise from such use. RELATING TO COMMUNITY SERVICES AND THE STATE HB 1406, HD1 HSG, JUD, FIN (HSCR102) HOMELESS PROGRAMS. Creates the Office of Homeless and Community services under the Status Department of Human Services and transfers the Office of Community Services from the Department of Labor and Industrial Relations and the homeless programs from the Hawaii Public Housing Authority to the Department of Human Services. (HB1406 HD1) RELATING TO THE HAWAII RULES OF EVIDENCE. JUD HB 349 Status Provides that if evidence of an alleged victim's character for aggressiveness is offered by an accused and admitted under paragraph (2), evidence of the same trait of character of the accused offered by the prosecution may be admissible. HB 1518 RELATING TO MOTOR VEHICLES. TRN, JUD, FIN (HSCR99) Authorizes motor vehicle towing companies to add the general excise tax to the fees charged to the owner of a motor vehicle left unattended Status on private or public property. HB 87, HD1 RELATING TO EDUCATION. EDN, JUD, FIN (HSCR19) Authorizes and obligates DOE to oversee and monitor students eligible for special education who are placed in private schools or facilities at Status public expense. Status CONSTITUTION, RELATING TO THE DISPOSITION OF PROJECTED EXCESS REVENUES.

Routes a portion of projected increases in general fund revenues to emergency and budget reserve fund established by law. Sets 7% as the

percentage that triggers the disposition.

HB 215 RELATING TO CAMPAIGN FINANCING. JUD, FIN

<u>Status</u> Organizes, clarifies, updates, and recodifies campaign finance laws.

HB 539 RELATING TO CAMPAIGN CONTRIBUTIONS. JUD

Prohibits a corporation or company from making campaign contributions directly from its treasury to a candidate, candidate's committee, noncandidate's committee, or political party. Permits a corporation or company to make a contribution of no more than \$25,000 from its treasury to one noncandidate committee established by the corporation or company. Allows a corporation's or company's

noncandidate committee to make campaign contributions to

candidates, candidate committees, other noncandidate committees, and

political parties in accordance with existing law.
