SB 691 RELATING TO LIQUOR COMMISSION EMPLOYEES. LBR, JGO

Repeals section 281-22, HRS, which allows liquor commission **Testimony** employees to support, advocate, or aid in the election or defeat of any

candidate for public office. Status

SB 823 RELATING TO FAMILY LEAVE. LBR

Requires employers to notify employees annually of their entitlement **Testimony** to family leave, as well as possible adverse impact of taking family

leave.
