SB 1664 RELATING TO EMPLOYMENT SECURITY. LBR, WAM
Adds definitions relating to partial unemployment and sets out

Testimony claimants' eligibility, claims filing, and registration requirements, and employers' reporting requirements for partial unemployment.

SB 642 RELATING TO PUBLIC EMPLOYEES. LBR, WAM

Testimony
Requires personnel directors to ensure that adjustments (including changes in wages and health and retirement benefits) for excluded civil service employees are at least equal to adjustments provided under collective bargaining agreements with counterparts within the

employer's jurisdiction.

SB 62 RELATING TO WORKERS' COMPENSATION. LBR

Testimony Requires independent medical examinations and permanent impairment rating examinations to be performed by physicians

Status mutually agreed upon by employers and employees or appointed by the

director of labor and industrial relations.

SB 63 RELATING TO WORKERS' COMPENSATION. LBR, WAM

Requires an employer to pay temporary total disability benefits regardless of whether the employer controverts the right to benefits.

Status

Specifies that the employee's ability to return to work is to be decided by the employee's treating physician. Convenes a working group. Effective upon approval for the convening of the working group; 7/1/10 if there is no consensus among the working group.

SB 695 RELATING TO WORKERS' COMPENSATION. LBR

Testimony
Requires the employer to continue medical services to an injured employee despite disputes over whether treatment should be continued, until the director of labor and industrial relations decides whether

treatment should be continued.

SB 688 RELATING TO EMPLOYMENT. LBR

Testimony Establishes job security requirements upon the divestiture of a covered

establishment.

RELATING TO PROCUREMENT.

Requires all offerors and subcontractors for construction contracts subject to the state public procurement code, to maintain or participate in a bona fide, state-approved apprenticeship program at the time of general bidding.

Decision Making to follow, if time permits.
