SB 236 RELATING TO JUSTIFIABLE USE OF FORCE. PSM, JGO

Testimony
Amends chapter 703, HRS, to remove requirement to retreat or surrender possession of a thing before the use of force is considered justifiable.

SB 478 RELATING TO DISASTER RELIEF. PSM, JGO

Activates provisions of the State's disaster relief law to apply to emergencies, except for enemy attack. Clarifies the use of the governor's emergency powers in response to a natural or manmade disaster. Limits the governor's powers to provide disaster relief or the length of time that the governor may provide disaster relief in specific circumstances without legislative authorization. States that, in certain cases, emergency powers in force prior to the effective date of this

measure expire at the end of the 2009 regular session unless reauthorized by the legislature.

SB 540 RELATING TO PUBLIC SAFETY. PSM, WAM
Establishes a state residential drug abuse program with an

SB 546 RELATING TO CORRECTIONS. PSM, WAM

Testimony
Requires the department of public safety to establish a pilot program on Oahu that electronically monitors committed persons who are permitted to live and work in the community in lieu of continued

incarceration. Appropriates funds.

SB 539 RELATING TO CORRECTIONS. PSM

Testimony

Reorganizes and renames the corrections program services division of DPS to the reentry services division, whereby the reentry services division will work closely with the furlough programs in each county

that are managed by the institutions division to ensure that the reentry

needs of inmates are being met.

SB 1149  Testimony  Status	RELATING TO THE DEPARTMENT OF PUBLIC SAFETY. Creates a new intake and reentry division within the department of public safety to house the existing intake services center, correctional program services, correctional industries, and, at the Oahu community correctional center, work furlough programs. SB 970  Testimony  Status	RELATING TO COMMITTED PERSONS' ACCOUNTS.  Amends section 353-20, Hawaii Revised Statutes, to permit the Director of Public Safety to direct the department to have one or more accounts for committed persons. Also states that the accounts are non-interest bearing and that no interest can be paid to committed persons on the individual accounts.	PSM, WAM
