PSM, WAM **SB 626** Requires office of veterans' services to pay directly to a mortuary for **Testimony** services and to transport the remains of a deceased veteran who joined the New Filipino Scouts between 10/06/1945, and 06/30/1947, and **Status** died after 06/30/1994, to the Philippines upon submission of an unpaid invoice. Appropriates funds. **SB 1132** RELATING TO VETERAN SERVICES. Increases effectiveness and efficiency by affirming that positions in the Hawaii National Guard sponsored youth and adult educational

Status programs are exempt from civil service requirements.

SB 898 RELATING TO CIVIL DEFENSE. PSM, JGO

Supports State Civil Defense's Shelter-in-Place initiative by exempting civil liability for care homes and schools, in addition to hotels, during

<u>Status</u> an officially designated emergency.

SB 1147 RELATING TO STATE DISASTER RELIEF. PSM, JGO

Clarifies that the governor has the authority to declare a disaster emergency. Requires the state civil defense division after the governor has proclaimed a disaster emergency, to report to the governor,

legislature, and each county mayor on the disaster, including specified

information.

SB 1169 RELATING TO PUBLIC SAFETY. PSM, WAM

Testimony
Requires theaters, public auditoriums, and other public meeting places that have no natural light source to be equipped with an emergency lighting system that will operate during an electrical power outage.
