HB 1204, HD2 (HSCR871) Testimony Status	RELATING TO TOURISM. Requires, for fiscal years 2009-2010 and 2010-2011 only, an additional distribution of not more than an unspecified amount of funds in Transient Accommodations Tax revenues to the Tourism Special Fund. (HB1204 HD2)	TSM, WAM
HB 1763, HD2 (HSCR873) Testimony Status	RELATING TO THE HAWAII TOURISM AUTHORITY. Repeals the Hawaii Tourism Authority. Establishes the Department of Tourism. Transfers the Convention Center Enterprise Special Fund, Tourism Special Fund, and Tourism Emergency Trust Fund to the Department of Tourism. Renames the Department of Business, Economic Development, and Tourism to the Department of Business and Economic Development. (HB1763 HD2)	TSM, WAM
