SB 161 RELATING TO EDUCATION. EDH/LBR, WAM Repeals salary ranges for teachers in the department of education. (SSCR126) **Testimony Status SB 163** RELATING TO EDUCATION. EDH, WAM Repeals statute creating district business and fiscal officers within the (SSCR9) department of education. **Testimony** Status **SB 164** RELATING TO THE FEDERAL GRANTS SEARCH, EDH, WAM DEVELOPMENT, AND APPLICATION REVOLVING FUND. (SSCR10) Expands the allowable use of the federal grants search, development, **Testimony** and application revolving fund to include monitoring and auditing. Changes the name of the fund to reflect the new allowable uses. Status **SB 754** RELATING TO AFFORDABLE HOUSING. EDH. (SD1) SB 863, SD1 RELATING TO THE HAWAII HOUSING FINANCE AND EDH, WAM DEVELOPMENT CORPORATION. (SSCR53) Makes necessary housekeeping amendments to chapter 201H, Hawaii Revised Statutes; authorizes the imposition of service fees to recoup **Testimony** program administrative expenses. (SD1) Status RELATING TO THE HAWAII TEACHER STANDARDS BOARD. SB 497, SD1 EDH, WAM Establishes an advisory committee to provide oversight of the Hawaii (SSCR161) teacher standards board and provide the governor with lists of nominees for appointment to the board; requires annual report of the **Testimony** advisory committee to the board of education and the legislature; **Status** authorizes the board to hire an executive director; authorizes the Hawaii teacher standards board to suspend its policies, rules, and standards when required by extenuating circumstances, and determine how it collects license fees (part I); authorizes the Hawaii teacher standards board to coordinate an effort that creates a data interface network to promote the free interchange of information among public

and private Hawaii teacher education institutions and the department of

education; appropriates funds (part II). (SD1)

RELATING TO TEACHERS. SB 1249, SD1 EDH, WAM Provides incentives for the recruitment and retention of public school (SSCR185) teachers. (SD1) **Testimony Status** SB 733, SD1 RELATING TO EDUCATION. EDH, WAM Clarifies the law for determining school impact fees for financing new (SSCR317) or expanding existing DOE schools or facilities. (SD1) **Testimony Status**
