SB 86 RELATING TO MAKUA. WTL, WAM

Testimony Establishes the Makua valley reserve commission to oversee preservation and restoration activities in Makua valley on Oahu.

SB 167 RELATING TO CONSERVATION CORPS. WTL, WAM

Requires the department of land and natural resources to establish a pilot conservation corps program to enable persons recovering from drug addiction and former inmates to participate in conservation and environmental protection. Appropriates funds for the pilot program.
