SB 580 Testimony Status	RELATING TO FORFEITURE. Clarifies that the forfeiture laws apply to violations of conservation and resources statutes and rules and to protection of caves, historic preservation, and the Kahoʻolawe island reserve.	WTL, JGO
SB 582 Testimony Status	RELATING TO KULEANA LANDS. Makes the office of Hawaiian affairs the trustee of any unclaimed kuleana lands. Prohibits quieting title to kuleana lands or claiming kuleana lands by adverse possession.	WTL, JGO
SB 1085 Testimony Status	RELATING TO CEDED LANDS. Prohibits the board of land and natural resources from selling, exchanging, or otherwise alienating ceded lands in the public land trust.	WTL, JGO
SB 475 Testimony Status	RELATING TO LANDS CONTROLLED BY THE STATE. Prohibits the sale or exchange of certain public lands considered to be ceded lands. Expires on decision of U.S. Supreme Court on pending appeal of related case.	WTL, JGO
SB 476 Testimony Status	RELATING TO LANDS CONTROLLED BY THE STATE. Requires two-thirds majority vote of the legislature to adopt concurrent resolution to sell or exchange certain public lands.	WTL, JGO
