"While I have no problem helping the museum and Iolani Palace, I question whether we should take the money out of this particular Fund. The Works of Art Special Fund generally purchases contemporary art from local living artists. So, the mission of the State Foundation of Culture and Arts and the two institutions are quite different. Remember, local living artists are small business people and are very vulnerable to economic

downturns. The purpose clause states that any loss could result in a loss of 2,357 jobs.

"So, because the arts community is a very vibrant community, I'm wondering whether we should take any money out of the Fund at this time. So, just wanted to express my reservations. Thank you."

Representative Mizuno rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I'll try to be brief. In support of Stand. Com. Report 1038. Mr. Speaker, this bill came along, Senate Bill 190, because someone who was married for 63 years, was unfortunately forced to be separated from her husband. This person is Terry Kaide. She's 86 years old, and she's a retired Clerk of the Third Circuit Court in Hilo.

"Her husband, Sydney, age 89, is a retired contractor, and they've been married for 63 years. Sydney is bedridden and diagnosed with bladder cancer. He's suffered some strokes, and so he's unable to talk, but Terry stays at his side, whenever she can. And, this is her words: 'Although he's unable to talk, he's tube-fed, he can see me, hear me, feel my touch. When he hears or sees people that are familiar to him, he's so overcome with joy and emotions. I want to live with my husband before the Lord takes us home. We don't have too much time left. I want to be able to wake up and see his face every morning, hold his hand, and sing his favorite songs. I miss him all the time, and I just want to be at his side. I want to hold his hand for more than an hour or two each day. In my silence, I'm suffering from hurt, guilt, confusion, and the injustice to my marriage.'

"Mr. Speaker, this bill came along because Terry Kaide wanted to do something about this. And, because of that, we passed out of your Human Services Committee, a bill to address that. The underlying laws actually have a good rationale. We want to have in a foster home two Medicaid clients and one private pay. The rationale is to have more Medicare low income families be allowed to live or reside in a care home.

"Unfortunately, it's not an airtight and perfect law, and this is the perfect example why. Because of Mrs. Kaide, we passed a law out of our committee, with the Department of Human Services helping us craft this piece of legislation to now allow a married couple, this would be the exception to the rule now, now you can have another private pay if you have a married couple, such as Terry and Sydney. This will also allow reciprocal beneficiary couples to be together. This will also allow siblings, and a parent or child, as well as best friends to be together.

"So, because of Mrs. Kaide and her steadfast commitment to this, she has opened her door to so many other people, so that they can live together. I just wanted to thank Mrs. Kaide, and let the people out there know that some of the best pieces of legislation are not crafted by the legislators themselves, but the people from the community. I totally support this bill, Mr. Speaker. Thank you, very much."

Representative Ward rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I also rise in support of Senate Bill 190. And out of respect for the lady who came all the way from Hilo and her daughters all the way from California, Mr. Speaker.

"This bill puts common sense back into government. It says that if you're married, you can live together. And, I think it's true to what

marriage vows say, that not, 'until sickness do we part,' but, 'not until death do we part.' Mr. Speaker, I would like to request submittal of this letter from the Governor, to Mrs. Kaide, that says that if we pass it, she will sign it, and as the request from Mrs. Kaide, upon her husband's birthday, April 11th, this could become law. That's what the goal is, that's what we're hoping for. Thank you, for your indulgence."

Representative Ward submitted the following letter from the Governor:

"February 18,2009

Ms. Charlotte Kaide  
Ms. Gale Sakaguchi

Aloha Ms. Kaide and Ms. Sakaguchi,

Mahalo for writing me regarding your mother's request to join your father in an adult community care foster home. I understand that your father is too frail to move into another facility at this time. I regret that the current law does not enable me to give you the result you seek.

As you may know, the State Department of Human Services licenses and regulates adult foster homes so low-income Medicaid clients can receive long-term care in family-like residential settings, as opposed to institutional hospitals and nursing homes.

Because there is a significant shortage of adult foster homes for Medicaid recipients, the law stipulates that no more than one private pay client can live in these two- or three-bed facilities.

Under Senate Bill 190, however, a couple who are private pay clients could live together in an adult foster home under certain conditions. My Administration opposed the original version of this bill, but is now working with the State Legislature on modifications that would apply to your situation.

If the House and Senate approve the amended bill in a timely manner, my policy advisors and I will give it careful consideration and I could sign it into law as early as April.

I hope this information is helpful. I also wish you and your family all the best as you strive to find a long-term care solution for your parents.

Representative Tsuji's written remarks are as follows:

"Mr. Speaker, I am in strong support of SB190, SD1, HD1, Relating to Community Care Foster Homes. I am a Hilo resident and friend of Mr. & Mrs. Sydney Kaide who, along with their children, are proponents of the measure. I sympathize and understand their plight as a married couple unable to live in the same community care foster family home because of the current law. The merits of this bill are many and I urge this Body to support the measure."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. "Basically, prisoners had their rights taken away, as part of their punishment for the crime that they committed. One of my other concerns is, this measure does not consider that a great deal of offenders use multiple means, multiple social security numbers, dates of births, and various addresses in their efforts to elude law enforcement.

"There is a real potential for voter fraud, as there is no way to verify previous residence information provided by the incarcerated person.

"I just believe that we're going in the wrong direction in giving too many criminals rights."

Representative Ching rose in opposition to the measure and asked that the her written remarks, and the remarks of Representative Pine be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Ching's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to S.B. 619 - Relating to Voting Rights, Incarcerated Person. I believe that this bill could put a financial burden on the State. I also believe this bill unfairly rewards those who have broken our laws. The Governor's Chief of Staff, Barry Fukunaga, states in his testimony that, "At present, Hawaii law does not permit offenders to vote during their period of incarceration. This limitation is a sensible one, as it denies voting rights to individuals who have been convicted and incarcerated for deliberate criminal activities. The vast majority of states do not give incarcerated offenders the right to vote."

"The Department of Public safety also has concerns and states in their testimony that "Any perceived disfranchisement of the offender by temporarily disallowing them to vote is done as a result of their willful criminal activities that victimize the community," and "This measure does not consider the fact that a great deal of offenders use multiple names, social security numbers, date of births, and various addresses in their efforts to elude law enforcement. This measure also fails to consider the fact that there is no way for the Office of Elections or various County Clerks to address the real potential for voter fraud as these entities have no way to verify the previous residence information provided by the incarcerated person."

"Thank you."

Representative Marumoto rose in support of the measure with reservations and asked that the remarks of Representative Pine be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Cabanilla rose to speak in support of the measure, stating:

"Mr. Speaker, in support. Just like my colleague in Ewa Beach, when I saw this bill, I had a lot of concern about it. What I did is, I called the introducer, who is my Senator, and asked him, "What are you doing?" And he said that we need to incorporate them as part of our society. We need to train them, as part of our society. And we have to give them responsibilities. They need to be a part of a bigger society. Therefore, we should allow them to vote.

"So, I just want to resonate what my Senator said to me, when I called him. Thank you, Mr. Speaker."

Representative Finnegan rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Rhoads rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

"Mr. Speaker, I rise in support of SB782 SD1 HD1 Relating to Employment Security. This measure provides unemployment insurance to those who are separated from their employment as a result of domestic violence in a manner that accommodates the legitimate interests of employers.

"SB782, SD1, HD1 also provides that domestic violence victim's suspension or discharge from work will not be considered misconduct under the law, and will not affect their eligibility for unemployment benefits. Women often fear being stalked while going to work, as well as fearing that violence could happen at home or at work. Fear of losing financial security is often the main reason domestic violence victims return to their abusers, so it is very important to allow victims to assert their independence with the assistance of unemployment benefits.

"Just this week a woman was shot to death in her car by a man she held a TRO against. Was she on the way to work? Must women who are abused and stalked leave their homes and eventually the state to find safety? This is a small part of the fight against domestic violence. If a woman is not economically independent how can she avoid going back to her abuser?

"For all these reasons, I urge the Members' support."

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and S.B. No. 579, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAIIAN LANGUAGE," passed Second Reading and was referred jointly to the Committee on Water, Land, & Ocean Resources and the Committee on Judiciary with Representatives Chang, McKelvey, Morita, Takai and Thielen being excused.

Representative Carroll, for the Committee on Hawaiian Affairs presented a report (Stand. Com. Rep. No. 1070) recommending that S.B. No. 1085, SD 2, as amended in HD 1, pass Second Reading and be referred jointly to the Committee on Water, Land, & Ocean Resources and the Committee on Judiciary.

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with reservations on Stand. Com. Rep. No. 1070. SCR 1070 prohibits the sale of ceded lands, until the unrelinquished claims of the Native Hawaiian people are resolved, or reconciliation between the State and Native Hawaiian people are no longer supported.

"The reason why I'm standing, however, is for what the Attorney General said, and said very passionately to the Committee. According to the AG, the bill raises the potential for additional federal court lawsuits against the State, by persons opposed to government programs that provide benefits to Native Hawaiians.

"I asked the AG, 'Do you really believe this? Is this your best legal opinion?' And he said, 'Definitely, yes.' And, he further stated that if that was not the case, OHA would otherwise not want to take the risk, and it would seem that their lawyers would be able to put that legal opinion in writing.

"My point, Mr. Speaker, is to vote with reservations, but to go on record, that if this bill ends up denying, lessening, or threatening Hawaiian rights, this Body will have been warned by the AG. It's simple as that, just going on the record. Thank you."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B.
